- All households evacuated are receiving case management services from the Ecumenical Council of Pasadena Area Churches.
- Housing placement services to each household (evaluation of housing needs, counseling, credits reports, housing search, lease negotiations, landlord outreach, rental applications, etc.) are being provided by Del Richardson & Associates to assist the evacuated households find housing.
- The Housing and Community Development Division is providing Section 8 Housing Choice Vouchers and HOME Tenant-based Rental Assistance Program Coupons to eligible households where appropriate. To date, 2 households have received Section 8 Vouchers, one from the PCDC and one from LACDC Housing Authority. In addition, 21 HOME Tenant Based Rental Assistance coupons have been issued.
- The Ecumenical Council of Pasadena Area Churches, Del Richardson & Associates and the Planning and Development, Housing and Community Development Division are working in cooperation to provide assistance and supportive services (health care, educational services, counseling services etc.) to all impacted households.
