SUBJECT: AGREEMENT FOR SEWER SERVICE AT 225 SAINT KATHERINE DRIVE AND 268 SAINT KATHERINE DRIVE, CITY OF LA CAÑADA FLINTRIDGE

## RECOMMENDATION:

It is recommended that the City Council adopt a resolution authorizing the City Manager to enter into two separate agreements among County Sanitation District No. 16 of Los Angeles County, the City of Pasadena, and the respective property owners governing the conveyance, treatment, and disposal of wastewater from single-family homes at 225 Saint Katherine Drive and 268 Saint Katherine Drive in the City of La Cañada Flintridge, and agreeing to the recordation thereof.

## BACKGROUND:

At many locations in the hillside area east of the Flintridge Sacred Heart Academy in the City of La Cañada Flintridge, the site geology severely restricts the use of septic tank systems. The City of La Cañada Flintridge has no sewerage system of its own in this area. However, the City of Pasadena owns and maintains an existing sewer line which serves the Flintridge Sacred Heart Academy, and the line has sufficient additional capacity to accommodate flows from the two subject properties.

The policy regarding sewer connections for properties within La Cañada Flintridge provides that this service may be made available provided it is done at no cost to the City of Pasadena. This policy is designed to safeguard public health by preventing potential contamination of the local ground water supply. However, if in the future there is another sewerage system that is operated by a public agency, and into which the owners of the above properties have a right to discharge, then the City will terminate the subject agreement and cease operation of its existing sewer facilities.

Since 1985, 23 separate agreements covering a total of 33 single-family home sites, a portion of the La Cañada High School, and the Hillside Developmental Learning Center have been approved under this policy.

The owners of the single-family home site at 225 Saint Katherine Drive, Ara James Najarian, Lynda Darlene Najarian, Armen Steve Najarian and Naira Najarian; and the owners of the single-family home at 268 Saint Katherine Drive, Leroy D. Sanders and Joan H. Sanders, both in the City of La Cañada Flintridge, have requested permission to connect to the sewer within Saint Katherine Drive by gravity flow. Approval of the sewer connection will eliminate the potential contamination threat that would be posed by the use of a septic tank system for the disposal of wastewater.

The owners of each of the subject properties will pay the City's one-time, non-refundable "Capacity Fee" in the amount of \$3,600, which is comprised of \$2,200 for the privilege of being allowed to connect to the Pasadena sewerage system, and \$1,400 for preparing and processing the agreement. The \$2,200 portion of the fee represents the contribution by a new user toward the cost of facilities paid for by previous users, which require repair and occasional upgrading or replacement. This charge has been determined by the Public Works Department to be a reasonable amount to charge for the provision of sewer service to sites in La Cañada Flintridge. The \$1,400 portion of the fee has been determined to be sufficient to offset City expenses incurred in connection with the preparation and processing of similar sewer agreements.


Future annual "User Fees" shall be equal to twelve times the monthly minimum fee for properties served by Pasadena's sewerage system, but not subject to the "Water Rate Ordinance" as per the rates established pursuant to Section 4.52.020 of the Pasadena Municipal Code. These fees shall be collected by preparing annual bills each July following the Council's annual adjustment, based on changes in the Consumer Price Index, of the rates.

Inasmuch as the site is located in County Sanitation District No. 34 of Los Angeles County, which is an inactive district, and as the sewer owned and maintained by the City of Pasadena is tributary to a sewerage system owned and operated by County Sanitation District No. 16 of Los Angeles County, the agreement contains that agency's requirements regarding the conveyance, treatment, and disposal of wastewater. After the agreement has been approved and executed by the City of Pasadena, it will be forwarded to County Sanitation District No. 16 for approval, execution, and recordation.

FISCAL IMPACT:

The \$3,600 non-refundable Capacity Fee collected pursuant to this agreement will be deposited in the Sewer Maintenance and Construction Fund (Account No. 7023-205).



A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASADENA AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT GOVERNING THE CONVEYANCE, TREATMENT, AND DISPOSAL OF WASTEWATER FROM SINGLE-FAMILY HOMES AT 225 SAINT KATHERINE DRIVE AND 268 SAINT KATHERINE DRIVE IN THE CITY OF LA CAÑADA FLINTRIDGE AND CONSENTING TO THE RECORDATION THEREOF

WHEREAS, the owners of a proposed single-family home site at 225 Saint Katherine Drive in the City of La Cañada Flintridge wish to connect to an existing sewer owned and operated by the City of Pasadena; and

WHEREAS, the owners of an existing single-family home at 268 Saint Katherine Drive in the City of La Cañada Flintridge wish to connect to an existing sewer owned and operated by the City of Pasadena; and

WHEREAS, the City of Pasadena is willing to accept wastewater from said home provided it is adequately compensated for facilities provided and services rendered; and

WHEREAS, said home site is located within County Sanitation District No. 34 of Los Angeles County, which does not own or operate a sewerage system for conveying, treating, and disposing of wastewater; and

WHEREAS, the sewer owned and operated by the City of Pasadena is tributary to a sewerage system owned either wholly or in party by County Sanitation District No. 16 of Los Angeles County; and

WHEREAS, Sanitation District No. 16 is willing to accept wastewater from said home provided it is adequately compensated for facilities provided and services rendered.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL of the City of Pasadena that the City Manager is hereby authorized to enter into, on behalf of the City, two separate agreements among County Sanitation District No. 16 of Los Angeles County, the City of Pasadena, and the respective owners at 225 Saint Katherine Drive, Ara James Najarian, Lynda Darlene Najarian, Armen Steve Najarian, and Naira Najarian; and at 268 Saint Katherine Drive, Leroy D. Sanders and Joan H. Sanders, and agreeing to the recordation thereof.
