**TITLE OF PROPOSED ORDINANCE:** AN ORDINANCE OF THE CITY OF PASADENA AMENDING TITLE 2, CHAPTER 2.05 OF THE PASADENA MUNICIPAL CODE TO CHANGE THE LOCATION OF THE REGULAR MEETINGS OF THE PASADENA CITY COUNCIL

**PURPOSE OF ORDINANCE:** This ordinance will change the location of the regular meetings of the City Council from the City Hall Council Chambers to the Pasadena Senior Center, located at 85 East Holly Street, Pasadena. This ordinance is necessary because the location of the regular City Council meetings will be moved from City Hall temporarily due to the City Hall retrofit project. Once the project is complete and the City Council chambers reopen, another ordinance would be necessary to change the location of regular meetings back to City Hall.

**REASONS WHY LEGISLATION IS NEEDED:** The Municipal Code currently provides that the regular meetings of City Council are to be held in City Hall. An ordinance is required in order to amend the Municipal Code and change the regular meeting location for the City Council.


**PROGRAMS, DEPARTMENTS OR GROUPS AFFECTED:** This ordinance will affect all groups that attend City Council meetings.

**AN ORDINANCE OF THE CITY OF PASADENA AMENDING TITLE 2, CHAPTER 2.05 OF THE PASADENA MUNICIPAL CODE TO CHANGE THE LOCATION OF THE REGULAR MEETINGS OF THE PASADENA CITY COUNCIL**

The People of the City of Pasadena ordain as follows:

SECTION 1. Title 2, Chapter 2.05 of the Pasadena Municipal Code is hereby amended by amending Section 2.05.060 Meetings-Regular, to read:

“The city council shall hold regular meetings each Monday at the hour of 5:30 p.m. in ~~Room 247 of the City Hall, 100 North Garfield Avenue, in the city.~~ the Multi-Purpose Room at the Pasadena Senior Center, 85 East Holly Street, in the City of Pasadena. **When any Monday falls on a legal holiday, the regular meeting shall be canceled.**”

SECTION 2. The City Clerk shall certify the adoption of this ordinance and shall cause this ordinance to be published in full text.

SECTION 3. This ordinance shall take effect upon its publication.
