ORDINANCE NO.

AN ORDINANCE OF THE CITY OF PASADENA AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF PASADENA ESTABLISHED BY SECTION 17.08.040 OF THE PASADENA MUNICIPAL CODE (ROSS GROVE LANDMARK OVERLAY DISTRICT)

The People of the City of Pasadena ordain as follows:

SECTION 1. The official map of the City of Pasadena as established by Section 17.08.040 of the City's Zoning Code is amended by modifying the boundaries of certain zoning districts established therein as follows:

By reclassifying from the WGSP-1B zoning [West Gateway Specific Plan, Ambassador College Campus east of Orange Grove Blvd. Residential must comply with the RM-16 (Mutli-family residential, 16 units per acre.) to WGSP-1B LD-6 (West Gateway Specific Plan, Ross Grove Landmark District) as shown on the map entitled "Ross Grove Landmark District" attached hereto as Exhibit A-1 and incorporated herein by this reference as if fully set forth herein, and on file in the City Clerk's office of the City of Pasadena. The legal description attached hereto as Exhibit A-2, is also on file in the City Clerk's Office of the City of Pasadena.

SECTION 2. Notwithstanding any provision of Title 17 to the contrary, on or after the effective date of this ordinance all future construction, exterior alterations, relocations or demolitions initiated by application for a building permit, land-use entitlement or building plan check for properties located within the boundaries of the Ross Grove Landmark Overlay District will require a Certificate of Appropriateness prior to the issuance of any building permits according to the Secretary of the Interior's Standards for Rehabilitation and the "Design Guidelines for Historic Districts," which includes a supplemental chapter for Ross Grove Landmark District, on file in the City Clerk's Office of the City of Pasadena.

SECTION 3. The City Clerk shall certify the adoption of this ordinance and shall cause this ordinance to be published in full text.

SECTION 4. This ordinance shall take effect 30 days from its publication.
