SUBJECT: Approval of Final Tract Map No. 53694, Being an Eight-Unit Condominium

Project at 785 South Marengo Avenue

RECOMMENDATION:

It is recommended that the City Council adopt the following resolution to:

- 1) Approve final Tract Map No. 53694; and
- 2) Authorize the City Clerk to execute the Certificate on the map showing the City's approval of said map.

BACKGROUND:

The subject tract map, being an eight-unit condominium project at 785 South Marengo Avenue, was reviewed and approved in tentative form by the Subdivision Committee on July 9, 2003.

The developer's engineer has completed the final map which has been checked by the County. Monumentation has been established and inspected by the County. Said map is now ready for the City Council's approval prior to recordation in the office of the County Recorder. The developer has complied with or provided surety for all the conditions of approval required by the City. A building permit had been issued and no additional discretionary actions are required.

The eight-unit condominium project is approximately 30 percent complete and is being constructed on a lot that had two multi-family buildings. The project is tentatively scheduled to be completed by March 2005. The project has resulted in an increase to the City's housing stock. The project is not subject to the requirements of the Inclusionary Housing Ordinance which is applicable to ten or more housing units.
