APPROVAL OF SUBMISSION OF THE 2005 CONTINUUM OF CARE HOMELESS ASSISTANCE APPLICATION TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD)

Recommendation of Chief Executive Officer: It is recommended that the Pasadena Community Development Commission ("Commission") adopt a resolution:

(1) Authorizing the filing with the U.S. Department of Housing and Urban Development (HUD), the 2005 Continuum of Care (CoC) Homeless Assistance Application for a funding request of \$1,909,816 for nine projects; and

(2) Authorizing the Chief Executive Officer to execute, and the Secretary to attest, the 2005 Continuum of Care Homeless Assistance Application and all other related documents, agreements and amendments. (Resolution No. CDR-235)

Ms. Ann Lansing, Program Coordinator, reviewed the agenda report and responded to questions.


