SUBJECT: Approval and Acceptance of an Easement Dedication for Public Street Purposes along the South Side of Orange Grove Boulevard East of Lake Avenue

RECOMMENDATION:

It is recommended that the City Council adopt the attached resolution approving and accepting a proposed easement dedication for public street purposes along the south side of Orange Grove Boulevard east of Lake Avenue.

BACKGROUND:


As a condition for the construction of the Walgreens drug store at 670 North Lake Avenue, the developer was required to dedicate to the City a four-foot wide strip of land along the south side of Orange Grove Boulevard east of Lake Avenue, including the land necessary to provide a 20-foot radius property corner rounding at the southeast corner of Lake Avenue and Orange Grove Boulevard, to improve pedestrian and vehicular access. The south side of Orange Grove Boulevard has an existing 12-foot wide sidewalk. The southerly four-foot wide strip of the sidewalk is on private property and is currently being used as a public walkway. The dedication would reflect its use as public right-of-way. Consequently, the developer has offered the grant of easement for public street purposes.

The proposed easement documents have been prepared by the Department of Public Works, executed by the developer, reviewed by the City Attorney's office and are now ready for approval and acceptance by the City Council. The property included in the proposed easement is legally described in text and is graphically shown on the attached Department of Public Works Drawing No. 5521.

FISCAL IMPACT:

No revenue will be generated by the approval of the dedication. The developer has paid all costs for preparing and processing the easement.



**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASADENA
APPROVING AND ACCEPTING AN EASEMENT DEDICATION FOR
PUBLIC STREET PURPOSES ALONG THE SOUTH SIDE OF ORANGE
GROVE BOULEVARD EAST OF LAKE AVENUE**

WHEREAS, the easement of a four-foot wide strip of land along the south side of Orange Grove Boulevard east of Lake Avenue at 670 North Lake Avenue to reflect its use as public right-of-way, including the land necessary to provide a 20-foot radius property corner rounding at the southeast corner of Lake Avenue and Orange Grove Boulevard, will improve pedestrian and vehicular access; and

WHEREAS, both the Department of Public Works and City Attorney's office have reviewed the proposed dedication;

EXHIBIT "A"

LEGAL DESCRIPTION

Grant of Easement for Public Street Purposes along the South Side of Orange Grove Boulevard, East of Lake Avenue.

That portion of Lots 8, 9 and 10 of Leighton and Merrill's Subdivision, in the City of Pasadena, as shown on a map filed in Book 24, Page 18 of Miscellaneous Records, in the Office of the County Recorder of the County of Los Angeles, State of California, described as follows:

Beginning at a point on the easterly line of said Lot 8, distant 10.00 feet southerly, along the easterly line thereof from the northeast corner of said Lot 8; thence, along said easterly line, South 0°02'36" West 3.98 feet to a line which is 40.00 feet southerly and parallel, measured at right angles from the centerline of Orange Grove Boulevard as it is shown on the City of Pasadena "Tie Notes" on file with the City of Pasadena; thence, along said parallel line, South 89°41'30" West 171.13 feet to a tangent curve concave southeasterly having a radius of 20.00 feet, the radius point of which is 20.00 feet, measured at right angles from the easterly line of the 10.00 foot right of way easement described in a document filed as Case No. 214918 in Book 692, Page 333 of Judgments; thence southwesterly 31.29 feet along said curve through a central angle of 89°38'54" to the easterly line of North Lake Avenue, 100.00 feet wide, as described in said Case No. 214918 in Book 692, Page 333 of Judgments; thence non-tangent from said curve, and along the said easterly line of Lake Avenue, North 0°02'36" East 23.86 feet along said easterly line, to the southerly line of the northerly 10.00 feet of said Lots 8, 9 and 10; thence along said southerly line North 89°41'30" East 191.00 feet to the **Point of Beginning**.

The herein described parcel of land has an area of 755 square feet, more or less.

Said Grant of Easement for public street purposes of that portion of Lots 8, 9, and 10 of Leighton & Merrill's Subdivision is shown on City of Pasadena Department of Public Works Drawing No. 5521, Sheet 1 of 1 on file in the Office of said department of said city.


