**TITLE OF THE PROPOSED ORDINANCE:**

AN ORDINANCE OF THE CITY OF PASADENA SUSPENDING SECTIONS 9.36.220 AND 9.36.230 OF THE PASADENA MUNICIPAL CODE RELATING TO LIMITATIONS ON HOURS OF OPERATION OF AMPLIFIED SOUND ON A SUNDAY FROM 9:00 AM – 10:00 AM AND NOISE SOURCES FOR A PERMITTED EVENT AT AREA H ON SUNDAY, SEPTEMBER 25, 2005 (THE AGA KHAN FOUNDATION'S PARTNERSHIP WALK)

**PURPOSE OF ORDINANCE:**

This proposed ordinance will temporarily suspend the hours of operation for amplified sound equipment allowed by the City's Noise Ordinance on Sundays by non-profit organizations from 9:00 a.m. to 10:00 a.m. for a permitted event at Area H during specified hours on Sunday, September 25, 2005. The enactment of this proposed ordinance is needed for this event to take place.

The City Council approved this request at the July 18, 2005 City Council meeting.

**REASON WHY LEGISLATION IS NEEDED:**

The Noise Ordinance was enacted by ordinance and can only be suspended by an ordinance of the City Council.

**FISCAL IMPLICATIONS:**

Any City costs that may be incurred for this event (i.e., sound meter reading, park clean up, etc.) are to be paid by the event promoter.


**ENVIRONMENTAL IMPACT:**




