Public Comments m - Public Hearing Northwest Commission - April 28, 2005

Homelessness:

- On any given night in Pasadena 30,000 individuals are at risk of becoming homeless
- > Ecumenical Council of Pasadena Area Churches (ECPAC) operates the only homeless prevention program for the homeless community in Pasadena.
- A local citizen states that she is homeless and is trying to obtain a Section 8 Rental Housing Voucher and even then there are so many barriers to getting housing, there are many places that do not accept the vouchers.
- > The majority of the residents in Pasadena that are becoming homeless are from the Northwest area of the City. Many are female heads of households with dependent children.
- The number of homeless women is increasing over the number of homeless men.
- > There are some persons who are chronically homeless and there are those persons who are homeless for the first time in their lives.
- > The community needs to help give women the resources to obtain permanent shelter.
- > Pasadena residents need to have a chance to continue to live in Pasadena.
- > Homeless issues for senior citizens and people of color are becoming more important.

Affordable Housing:

- > There are residents of the City who are recently married and are finding that they are unable to find affordable housing in Pasadena.
- The City needs to provide affordable housing especially for people who are working, earning a decent wage and still find that they cannot afford the cost of housing.
- ➤ 15% of apartments should be made available for local residents as affordable housing
- ➤ Residents want to see something in the Five-Year Consolidated Plan about the enforcement of rules and regulations that have already been adopted by the City. (i.e., Inclusionary Housing Ordinance).
- > Often seniors who lose their spouse/mate can no longer afford their current living situation.
- > There is a large need for more housing, especially for people of color and for seniors.


Economic Development:

- > There are 4 police dedicated to enforcing day laborer laws and this is preventing day laborers from getting employment. The day laborers, in turn cannot support their families thus leading to the family becoming homeless.
- > Pushcart vendor enforcement also presents the same problem. It prevents the vendors from working and unemployment leads to homelessness.
- > There should be open communication between the local day laborers and pushcart vendors
- > The cost of living in Pasadena is increasing and that is troubling. This is why we work so hard every day.
- > Please look at (examine) the health ordinances that affect our work.

- Push cart vendors can only remain in one place for 5 minutes per business transaction and then must immediately proceed with the heavy carts. This is not enough time.
- Pushcart vendors want the ordinances restructured to be more realistic.
- > The vendors request that meetings be held to discuss the local ordinances.
- > The Push Cart vendor program was originally intended to help individuals advance economically.
- It saddens many people that there are so many restrictions on their ability to sell and thereby improve the quality of fife for their families.
- > Push cart vendors have to work out of the commissary due to health department regulations. If the regulations are enforced exactly as they are written they may put the vendors out of business.
- > Pushcart vendors are asking the Commission for assistance with the regulations that apply to the large trailers (food trucks).
- In Pasadena, the ordinances are impacting the trailers and the vendors would like to dialogue about the situation.
- When permits were first given many years ago, the regulations were not the same but now police will enforce the strict regulations at the disadvantage of the vendors. This enforcement could potentially create more homeless individuals and families in Pasadena.
- Instead of punishing those that have obtained their operating permits, the City should work to enforce the laws against illegal vending.
- > The vendors are trying to work and support their families.

General Comments:

- > Partnerships among local non-profits, businesses and the City should be encouraged to make more services available.
- > It is imperative that our youth obtain a good education. We need to be aware of the consequences of poor education and a lack of money for college.
- ➤ How do we bring together the Five Year Consolidated Plan and include issues like education and homeless prevention?
- > The City needs to involve businesses in this effort.




