

A RESOLUTION OF THE CITYCOUNCIL OF THE CITY OF PASADENA REGARDING THE PASADENA ENTERPRISE ZONE

RESOLUTION NO
WHEREAS , on March 20, 1984 the Governor of the State of California signed into law Government Code Section 7070 et seq.), thereby creating a State Enterprise Zone Program; and
WHEREAS , in January, 2006 the State Department of Housing and Community Development issued guidelines for the submission of a preliminary and final application for the designation of 23 new enterprise zones; and
WHEREAS, the City of Pasadena is applying for designation as an enterprise zone with the location and boundaries shown in Exhibit A; and
WHEREAS, the City of Pasadena desires to promote economic development in the application area, including without limitation, the retention and expansion of existing businesses and the creation of expanded job opportunities.
NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pasadena that:
 The designation of the enterprise zoned area is necessary in order to assist in attracting private sector investment to the application area;
 The City Council agrees to complete all actions stated within the preliminary and final application should the application be awarded designation;
 The City Council hereby proposes the boundaries as shown on Exhibit A, for designation by the State Housing and Community Development Department as an enterprise zone and Exhibit B as the target employment areas;
 The designation of the Enterprise Zone and Target Employment Areas will not cause any detrimental environmental impacts on the proposed area.
5) The Director of the Planning and Development Department is directed to submit the application for designation of the City of Pasadena Enterprise Zone to the California Housing and Community Development Department for acceptance and approval.
6) This resolution will take affect immediately upon its adoption.



EXHIBIT A ENTERPRISE ZONE BOUNDARY MAP




