APPROVAL OF FINAL TRACT MAP NO. 060834, BEING A SIX-UNIT

CONDOMINIUM PROJECT, AT 97 NORTH WILSON AVENUE

RECOMMENDATION

It is recommended that the City Council adopt the following resolution to:

1) Approve Final Tract Map No. 060834; and

2) Authorize the City Clerk to execute the Certificate on the map showing the City's approval of said map.

BACKGROUND

The subject Final Tract Map, being a six-unit condominium project at 97 North Wilson Avenue, was reviewed and approved in tentative form by the Subdivision Committee on April 15, 2005.

The developer's engineer has completed the final map which has been reviewed by the County. Said map is now ready for the City Council's approval prior to recordation in the office of the County Recorder. The developer has complied with or provided surety for all the conditions of approval required by the City, including monumentation. A building permit has been issued for the development of the site. No additional discretionary actions were required.

Construction on the project began in July 2005 and is approximately 85 percent completed with the remaining 15 percent tentatively scheduled to be completed in April 2007. The project is being constructed on the site of a three-unit apartment building that was demolished in July 2005. The existing tenants were paying fair-market rents and relocated in February 2005.

BACKGROUND (Continued)

The project consisting of six condominium units is not subject to standards of the Inclusionary Housing Requirements, Chapter 17.42 of the PMC, which is applicable to newly constructed residential dwelling units of ten of more or subdivision maps consisting of ten or more residential lots. The property owner has satisfactorily demonstrated compliance with the requirements of the Tenant Protection Ordinance – Pasadena Municipal Code (PMC) Chapter 9.75 by compensating the dislocated tenants.

FISCAL IMPACT

The developer has paid for all costs to prepare and process the subdivision documents. Approval of this action will generate additional revenue to the City in an amount to be determined later in the form of property taxes.
