Desiderio due grand opening

had not until this week ever been on the actual property of the Desiderio Army Reserve Center beneath the Colorado Street Bridge.

Most of us in-mufti types would be in that boat. While the large site, with its government-issue buildings both large and small and acres of empty asphalt, looks disused, a visitor finds it is not.

In its own way, it is teeming with military activity. A number of uniformed Army personnel are in residence, in camouflage, writing memos, requisitioning supplies, thanking God for their delightfully dull posting.

All the current action at Desiderio revolves around its future, not its present.

As most readers know, the Pasadena City Council ordered that the baby be split when awarding the site to Habitat for Humanity for future use as home to nine new bungalows of affordable housing.

But that's OK. It was a good call. As is the point of that fable, no babies were actually split.

Yes, the council directed Habitat to negotiate with its arch-rival proposers, the California Art Club/Arroyo Seco Foundation. And that is as it should be. The bungalows are to be set back close to the Arroyo banks beneath the looming former Vista del Arroyo Hotel.

There is clearly room galore for Desiderio to host as well the modest proposal of the combined art and environmental entities, both a century old, both doing the Lord's work.

After actually going there, which I recommend to all who believe they have an opinion on this subject, that is one of my three clear findings.

The second is that, believe it or not, the big buildings on the site are worth saving — important, even, to save. From the outside, they are no oil paintings, as they say. A little non-G.I. sprucing up, some clinging vines, will take care of that. From the inside, they are unexpectedly magnificent.

The view of the arches of the Colorado Street Bridge from the north wing through clerestory windows is gorgeous. It is a voluminous, solidly built, perfect space for art and environmental exhibits. These buildings are a cultural resource for Pasadena and should not be torn down. Third finding: After the bungalows are built, and with some sheds and outbuildings razed, there will still be acres and acres of fine open space at Desiderio. The asphalt will be jackhammered away. The native plants will return. Bunnies, no doubt, will frolic.

Bickering factions, pay heed to "Admiral" Steve Madison here. "Cancel all shore leave," the councilman said, until successful compromise is reached. He's right. Desiderio will be happiest with all four tenants: Habitat, the California Art Club, the Arroyo Seco Foundation — and all that wonderful plain outdoors.

I cannot believe I am writing one more letter in support of the Arroyo Center's combined project with Habitat for Humanity at the Desiderio site. I was thrilled to see on the City's web site, the City Manager's recommendation for the combined project to "save" the buildings at Desiderio (reduced by 75 feet) and to allow Habitat their court yard housing. and feel, while there has been some flip-flopping, it is a pretty good representation of what people who live there want.



Dear Mayor Bogaard and Council Members:

The following comments summarize my <u>personal</u> views on this matter only, in that I am active in several organizations with differing views on the matter.

I support the Planning Commission recommendation which was originally accepted and adopted by the Council, and urge you to reaffirm your adoption of this recommendation. Therefore, please reject that portion of the Staff Recommendation which reduces the amount of natural Open Space on the site to about 50% in place of 75%.

The Planning Commission recommendation stressed two key points which should take top priority in your decision process: 75% natural Open Space, and the Bungalow Court design for the Habitat houses.

Reducing the natural Open space to about 50% or so of the site in order to save some portion of the existing building degrades the Open Space aspect of the site and leaves the site overdeveloped. Further, the community is left with a significant portion of an unsightly building which is out of character with the Arroyo -- an approach specifically rejected by the Planning Commission.

Further, more attention should be paid to siting the Arroyo Environmental and Nature Center primarily in Hahamongna, not here. Certainly, there can be a small Environmental and Nature Center annex incorporated into the Art Center on the Desiderio site, but, in my view, providing so much space to an Environmental and Nature Center on the Desiderio site means that the Nature Center that is so desired by the community adjacent to Hahamongna may never happen.

The Bungalow Court design best sites the houses adjacent to the existing public street, and, best reflects and incorporates Pasadena's architectural and cultural history. The alternative design for the houses presented at the last Council discussion should be rejected.

Thank you for your attention to my comments.

Dear City Council Members, the City Manager and other staff members:

The entire Foundation Board of La Casita has been in favour of the Arroyo Center for Art and Education once we heard about the project. We find it incredulous and unnecessary that the Council wishes to demolish any bit of the two large buildings on the site. Once you have been through them, (I suggest those of you who haven't, do so), it is easy to see they can be re-used/remodeled aesthetically at a much more economic and environmentally friendly manner, than to be torn down or reduced significantly. I understand you are thinking of granting Habitat's demand of removing 100 feet from the large building to make room for Habitat's circular housing design. This doesn't need to happen at all, and we encourage you to reject this. Why they want a circle is beyond me, as I wouldn't want to be looking into _/all/_ of my neighbors' front yards, but would rather have an uninterrupted view of the bridges and my own front yard. If Habitat insists on having their courtyard plan, there is plenty of unused land on the 5 acre site to move the houses to the north, closer to the bridge and those views, and closer to the other bungalows and condos next door under construction, including them in that small neighborhood (which I understand is one of their goals).

There is plenty of room there, and their houses won't be butted up right against the Arroyo Center.

I encourage you to take another look at keeping those buildings in their entirety, and either move Habitat's circular plan to the north, or spread the houses on a more linear plan.

I am also concerned about your plans to control re-sales on these homes, should you wish to maintain this site for low-income families. It is not enough for Sonya, the representative of Habitat, to say to the Council "the home owners won't own the land, so it is not a problem".

Not owning the land does not preclude re-selling the homes for neighborhood market prices, as you see in leaseholds all over the world. I mentioned this to Chris Holden, who says the homeowners will have to agree to covenants, most of which will expire in 20 years. Any family who own a home close to that 20 year expiration date will become instant millionaires and your goal of low-income housing disappears.

There are ways to mitigate this, and I am happy to discuss this further with you. Thank you for your attention.

Dear Mayor and Council Members,

Following is an email that John and I sent to Steve Madison regarding the Desiderio project.

I did sign the orginal petition for the Environmental/Art space because at the time it appeared to be one of the best choices amongst the many others. However, since that time, Habitat reduced its footprint and was approved by the Planning Commission and Council and actually is very compatible with the neighborhood. So I definitely supported that decision. I do wonder how many people signed the original petition for Art Club as I did, but now are not supportive of that expanded project or if they know how the project has expanded since the Feb. meeting at Council. Nine bungalow units with a courtyard recommended by Planning and Council fit into the neighborhood much more than the expanded use now proposed by the Calif Art Club.

I thought at the Feb. council meeting your suggestion for Habitat to work with Cal. Art Club to see if there was compatible use seemed to be generous, and the recommendation for the Art Club to build a smaller building seemed as though it would be feasible. But now it appears that the Art Club project has overshadowed the proposal for Habitat. Their new proposal is for a museum, gallery, teaching space, and an environmental teaching/learning space. I support all of those things in general, but am not in favor of all of that in a residential neighborhood. It just seems to be too much to add to S. Arroyo Blvd., and would force Habitat to change its plan for locating the 9 bungalows. What happened to their idea of a small environmental/art space?

Isn't the property zoned for residential?

I also think that our neighborhood is bearing the burden of poor planning with the Polyzoides project reaching under the bridge all the way down to Arroyo Blvd. I am now fearful that another large scale project which appears to be incompatible with the neighborhood will once again bring much more traffic. We now have an opportunity to enhance this space with affordable housing and more open passive space for use by all residents of the community.

I ask that the Council review its orginal intent for small bungalows at the site and leave the remaining space open.

Also, having been on the Board of the Armory Center for 20 years, I know that once an organization moves into a space there is continual operating costs and I do wonder how the care and upkeep of so many buildings and programs can be sustained.
