**SUBJECT: RESOLUTIONS APPROVING PROGRAM SUPPLEMENT AGREEMENT NOS. 074-N AND 075-N TO ADMINISTERING AGENCY-STATE AGREEMENT NO. 07-5064R FOR PARKVIEW AVENUE AND ROSE BOWL DRIVE STORM DRAIN DAMAGE REPAIRS**

## **RECOMMENDATION**

It is recommended that the City Council:

1. Adopt a resolution approving Program Supplement Agreement No. 074-N for Parkview Avenue to Administering Agency-State Agreement No. 07-5064R between the City of Pasadena and the State of California, acting through the California Department of Transportation (Caltrans), and authorizing the City Manager to execute the same on behalf of the City.
2. Adopt a resolution approving Program Supplement Agreement No. 075-N for Rose Bowl Drive to Administering Agency-State Agreement No. 07-5064R between the City of Pasadena and the State of California, acting through Caltrans, and authorizing the City Manager to execute the same on behalf of the City.

## **BACKGROUND**

The State of California, acting through Caltrans, administers certain Federal-Aid funds which are paid to the City of Pasadena pursuant to the provisions of Administering Agency-State Agreement No. 07-5064R entered into by the parties on April 3, 2007. This agreement reflects the provisions of the Legislature of the State of California by which certain Federal-Aid funds are made available for use on local transportation related projects. Before Federal-Aid funds will be made available for use on local transportation related projects, it is necessary for the City and Caltrans to enter into a supplemental agreement to establish terms and conditions applicable to the project and to the subsequent operation and maintenance of that completed facility.

The City applied for Emergency Relief Funds from the Federal Highway Administration (FHWA) in the amount of \$941,074 and on June 6, 2005, Caltrans notified the City that the "Slope and Street Repair - 2005 Winter Storms" project was eligible for funding. This project provides for the permanent restoration of two streets damaged during the heavy rain storms in the winter of 2005: Parkview Avenue between Yocum Street and West Washington Boulevard; and Rose Bowl Drive between Rosemont Avenue and North Arroyo Boulevard. The repair work includes the following:

- **Parkview Avenue** - Approximately 200 feet of slope repair and roadway reconstruction are necessary. This slope repair required the excavation and recompaction of approximately ten feet of soil below the existing roadway. The roadway reconstruction included the installation of curb and gutter, asphalt concrete pavement and guard rail. The cost for this portion of the project totaled \$327,000, with \$37,508 in funding provided as the local match by City and the remaining funding of \$289,492 provided by Federal funds.

The construction work on Parkview Avenue has been completed. Upon execution of the agreement, the City can invoice the State for reimbursement.

- **Rose Bowl Drive** - Approximately 300 feet of slope repair and roadway reconstruction and 600 feet of arroyo stone wall repair are necessary. The slope repair will require the excavation and recompaction of soil below the existing roadway. The roadway reconstruction will include the installation of asphalt concrete pavement and guardrail. The cost for this portion of the project totals \$732,000, with \$83,961 in funding provided as the local match by the City and the remaining funding of \$648,039 provided by Federal funds.


The construction work on Rose Bowl Drive is scheduled to begin in late Summer 2008 and to be completed in Fall 2008.

The Public Works Department and the City Attorney's Office have reviewed Program Supplement Agreement No. 074-N for Parkview Avenue and Program Supplement Agreement No. 075-N for Rose Bowl Drive and both are ready for approval.


**FISCAL IMPACT**

The local match is comprised of \$41,092 from Street Occupancy Rental Charges and \$80,377 from Traffic Congestion Relief Funds. The remaining \$937,531 will be provided on a reimbursement basis through Emergency Relief funds from the FHWA. Approval of Program Supplement Agreement Nos. 074-N and 075-N are prerequisites for the receipt of Federal-Aid transportation funds through the State for the Parkview Avenue and Rose Bowl Drive repair work.




