TITLE OF PROPOSED ORDINANCE

AN ORDINANCE OF THE CITY OF PASADENA AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF PASADENA ESTABLISHED BY SECTION 17.20.020 OF THE PASADENA MUNICIPAL CODE TO CHANGE THE ZONING DESIGNATION FOR 505 **SOUTH WILSON AVENUE**

PURPOSE OF ORDINANCE

This ordinance implements and codifies the zoning map amendment approved by the City Council on March 3, 2008. The purpose of this ordinance is to amend the zoning map to change the existing zoning at 505 South Wilson Avenue from RM-32 (Multifamily Residential District, 32 dwelling units/net acre) to PS (Public and Semi-Public).

REASON WHY LEGISLATION IS NEEDED

This ordinance is needed to allow Caltech to implement its School Master Development Plan. This change is consistent with the General Plan and Zoning Code.

PROGRAMS, DEPARTMENTS OR GROUPS AFFECTED

The Planning and Development Department will implement the ordinance.

FISCAL IMPACT

There will not be an immediate fiscal impact as a result of this amendment to the zoning map. Development fees will be collected by the Planning and Development Department from any future development proposed on the site.

AN ORDINANCE OF THE CITY OF PASADENA AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF PASADENA ESTABLISHED BY SECTION 17.20.020 OF THE PASADENA MUNICIPAL CODE FOR THE PARCEL AT 505 SOUTH WILSON AVENUE

The People of the City of Pasadena ordain as follows:

SECTION 1. This ordinance, due to its length and the corresponding cost of publication will be published by title and summary as permitted by Section 508 of the Pasadena City Charter. The approved summary of this ordinance is as follows:

"Summary

"Ordinance No. ______ amends the official Zoning Map as established by Section 17.20.020 by modifying the boundaries of certain zoning districts established therein as follows: By reclassifying the existing zoning from RM-32 (Multi-family Residential District, 32 dwelling units/net acre) to PS (Public and Semi-Public) for the parcel located at 505 South Wilson Avenue (Assessor Parcel Number 5327-003-013) as shown on the map titled "Amendment to Zoning Map of the Parcel at 505 South Wilson Avenue from RM-32 (Multi-family Residential District, 32 dwelling units/net acre) to PS (Public and Semi-Public)," attached to and incorporated into the Ordinance as Exhibit A. The map is on file in the City Clerk's Office of the City of Pasadena.

Ordinance No. _____ shall take effect 30 days from its publication."

SECTION 2. The official map of the City of Pasadena as established by Section 17.20.020 is amended by modifying the boundaries of certain zoning districts established therein as follows:

By reclassifying from the existing zoning from RM-32 (Multi-Family Residential District, 32 dwelling units/net acre) to PS (Public and Semi-Public) for the parcel located at 505 South Wilson Avenue as shown on the map entitled "Amendment to Zoning Map of the Parcel at 505 South Wilson Avenue from RM-32 (Multi-family Residential District, 32 dwelling units/net acre) to PS (Public and Semi-Public)," attached hereto as Exhibit A and incorporated herein by this reference as if fully set forth herein.

SECTION 3. The City Clerk shall certify the adoption of this ordinance and shall cause this ordinance to be published by title and summary.


