#### TITLE OF PROPOSED ORDINANCE:

AN ORDINANCE OF THE CITY OF PASADENA AMENDING CHAPTER 2.100 OF TITLE 2 CONCERNING THE MEMBERSHIP OF THE HAHAMONGNA WATERSHED PARK ADVISORY COMMITTEE

### PURPOSE OF ORDINANCE:

The Hahamongna Watershed Park Advisory Committee ("the Committee") was created in 1997 and is currently made up of the members of the Recreation and Parks Commission, two members of the Northwest Commission and two members of the Environmental Advisory Commission. In 2000, the membership of the Recreation and Parks Commission was reduced from 11 to 9 by Ordinance No. 6820; however, the size of the Committee was not changed to reflect the reduction. The purpose of this ordinance is to reflect the resulting change in membership requirements for the Committee from 15 members to 13 members.

#### **REASON WHY THIS LEGISLATION IS NEEDED:**

Pursuant to Section 410 of the City Charter, the City Council has authority to modify the organization of city operations by amendment of the Pasadena Municipal Code. This ordinance is necessary for consistency in municipal code provisions as a result of the change in size of the Recreation and Parks Commission.

SECTION 1. Title 2, Chapter 2.100, Section 2.100.120 (A) of the Pasadena Municipal		
Code is amended to read:

A. There shall be and There is created a fifteen-member (15) a thirteen-member		
(13) Hahamongna Watershed Park Advisory Committee composed of the nine (9) members of		
the commission, two (2) members of the northwest commission and two (2) members of the		
environmental advisory commission. The northwest commission and the environmental advisory		
commission shall designate the members of their respective bodies to serve on this advisory		
committee."		
SECTION 2. This ordinance shall take effect upon the date of its publication.
