I see that sewer rate increases are on the City Council agenda for Monday evening. I note that the rates seem to be increasing for every customer, yet the only comparison analysis and impact analysis is made for residential customers.

If rates are being increased across the board, it would seem appropriate to have the rate comparisons and impacts on business customers included in the report, as well. It might also be appropriate to take some time to communicate with business and commercial property owners before moving forward with a very high percentage rate increase.

Also, has there been any consideration given to restructuring rates so that the costs are borne more appropriately by those who most impact the system and whose service is most costly to provide?

Pending some outreach and informational meetings with Pasadena's business community, I would request that you hold this agenda item.
