SUBJECT: AN UNCODIFIED ORDINANCE OF THE CITY OF PASADENA GRANTING NON-EXCLUSIVE RENEWAL FRANCHISES FOR SOLID WASTE COLLECTION TO SIXTEEN (16) APPLICANTS.

TITLE OF PROPOSED ORDINANCE:

AN UNCODIFIED ORDINANCE OF THE CITY OF PASADENA GRANTING NON-EXCLUSIVE RENEWAL FRANCHISES FOR SOLID WASTE COLLECTION TO SIXTEEN (16) APPLICANTS.

PURPOSE OF ORDINANCE:

On April 28, 2008 and May 19, 2008, the City Council held public hearings on renewal applications for sixteen (16), non-exclusive solid waste franchises. All of the sixteen (16) applications were subsequently approved by the City Council, which directed the City Attorney to prepare the necessary ordinances granting the renewals and authorized the City Manager to enter into the franchise agreements.

Each franchise is for a first period of twelve months, with up to four additional renewal terms of one year, each, at the option of the City Manager. Each franchise is to commence according to written franchise agreements and if the franchisee otherwise meets all of the requirements for conducting this business in the City of Pasadena. The franchise agreements provide that any Franchisee not meeting the 60% annual recycling diversion rate and 75% for construction/demolition debris as measured from the effective date of the franchise agreement shall be subject to termination or suspension. New language will be added to each franchise agreement consistent with the pending ordinance changes approved by the City Council at its meeting of February 11, 2008, for example, compliance with Diesel emission standards, to require demonstration of compliance with regional and state vehicle emission standards and to allow termination, suspension or non-renewal for non-compliance.

The following applicants were approved and are granted renewed Franchises pursuant to the terms of the attached Uncodified Ordinance.


REASONS WHY LEGISLATION IS NEEDED:

ENVIRONMENTAL IMPACTS

The Environmental Administrator has determined that the proposed ordinance is exempt from the California Environmental Quality Act (CEQA) under CEQA Guidelines Section 15061(b)(3), which states the following: "[t]he activity is covered by the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment. Where it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment, the activity is not subject to CEQA."



ORDINANCE NO. \_\_\_\_\_

AN UNCODIFIED ORDINANCE OF THE CITY OF PASADENA GRANTING  
NON-EXCLUSIVE RENEWAL FRANCHISES FOR SOLID WASTE  
COLLECTION TO 16 APPLICANTS.

The People of the City of Pasadena ordain as follows:

WHEREAS, on March 17, 2008, the City Council of the City of Pasadena considered two (2) renewal applications for non-exclusive solid waste collection franchises and adopted Resolution No. 8837, after determining that said applications comply with Chapter 8.61 of the Pasadena Municipal Code;

WHEREAS, on April 14, 2008, the City Council of the City of Pasadena considered fourteen (14) renewal applications for non-exclusive solid waste collection franchises and adopted Resolution No. 8845, after determining that said applications comply with Chapter 8.61 of the Pasadena Municipal Code; and

WHEREAS, said Resolutions were duly published, and;

WHEREAS, duly-noticed public hearings pursuant to said Resolutions 8837, and 8845, were held, respectively, on April 28, 2008, and May 19, 2008; and

WHEREAS, after reviewing each application, and after public hearing, it was determined that each of the sixteen (16) applications complies with Chapter 8.61 of the Pasadena Municipal Code, and each applicant has agreed to comply with all provisions of this Chapter, including but without limitation, required recycling diversion rates, and;

NOW THEREFORE, the People of the City of Pasadena ordain as follows:

SECTION 1. Pursuant to Chapter 8.61 of the Pasadena Municipal Code, a separate, non-exclusive, solid waste collection franchise is hereby granted to each of

the following applicants, listed by name and business address, according to the terms and conditions set forth in the text of this ordinance and to the terms and conditions of a separate franchise agreement to be executed by each franchisee:

SECTION 2. Each separate grant of franchise is based on the certification of each franchisee that it shall comply with all of the provisions of Chapter 8.61 of the Pasadena Municipal Code, including, but without limitation the provisions of Section 8.61.175, which establish a contract requirement of minimum recycling diversion rates which must be met by each franchisee and liquidated damages for each franchisee for failing to meet those rates. Each franchise shall be for a first period of 12 months, commencing as of July 1, 2008, if a written franchise agreement has been fully

executed by the franchisee and all other requirements of Chapter 8.61 of the Pasadena Municipal Code have been met by that franchisee. Each franchise may be extended for up to four additional renewal terms, at the option of the City Manager, and according to the provisions of Section 8.61.120 of the Pasadena Municipal Code, with each renewal term being a term of one year.

SECTION 4. Each separate grant of franchise is based on the agreement of each franchisee that it shall comply with all of the regulatory provisions duly approved by the City Council at its meeting of February 11, 2008.

SECTION 5. The city clerk shall certify the adoption of this ordinance and shall cause this ordinance to be published in full text.

SECTION 6. This ordinance shall take effect upon the expiration of thirty days after its publication.
