I ask you to OPPOSE the proposal to designate Whispering Waters a Historic Landmark. There are many owners opposed to this designation and thus I ask your support. I feel that a designation of this magnitude should only be made if there is close to unaninous support and there is not.

This is a moderaely priced condominius complex composed of 30 owners, many with limited funds. Currently there is considerable deferred maintenance that needs to be done at a significant cost. These items need to be given priority status. Most will not be renovations of a historic nature. Owners have limited funds.

One of the initial primary architectural features of Whispering Waters was the extensive use of water and fountains. At its inception this was practical, as well as aesthetic, as it was part of the air conditioning system for the building. Today this technology is obsolete. Currently our governor has declared a state of drought throughout California. Although the current crisis may somewhat subside it will no go away. If the complex is restored historically water would be an important part of the appearance. I cannot support a project that would waste water and I am aware that the City has been encouraging water conservation.. It would be better to go "green" and have a small water feature that recycles and has considerably less loss of water from evaporation. It would still be Whispering Waters. Furthermore the bid for restoration of the front, including the ponds, is \$450,000.00 (\$15,000.00) per owner. This is prohibitive. The owners voted this down.

I request that you vote against the proposal to make Whispering Waters a Historic Landmark and allow the democratic processes to continue amongst the owners and the Board without added restrictions.

I've already heard back from several owners about supporting WWA to be named an historic landmark. I have not heard from you, however. I would appreciate having a conversation or getting an email back, or a phone call, so I know what your thoughts are. Can you please let me know if:

- 1. You support WWA being designated as an historic landmark
- 2. You don't care one way or the other about WWA being a historic landmark
- 3. You're opposed to WWA being designated an historic landmark

I am quoting below some of the information Mary Miller has been sending out to owners (thank you Mary.) She attended the meeting last Monday. There have been many mails flying with conflicting information and misinterpreted information, so I just wanted to reiterate some of the information Mary has been sharing that came from the City of Pasadena Design & Historic Preservation staff. She summarized the information very well.

- 1. Although getting the property tax reduction is not guaranteed, it is a certainty that WITHOUT the historic designation, we won't even have a chance to get a reduction. 2. The City stated at the meeting Monday night that on average, owners in historic buildings have secured a 52% reduction, and in some cases it has been as high as an 85% reduction. That would be a nice benefit, especially for those of us who have purchased in the last 5-7 years. [Note from Marion: this benefit stays with the property, not the owner, so it's also a benefit for anyone who is selling or thinking of selling].
- 3. In addition, historic status properties carry a certain "cachet" with buyers and are generally considered more desirable.
- 4. Finally, having the historic status can actually save money because when we do repairs on the building, we could be exempt from bringing it up to current code, which would not be an option without the historic status.
- 5. After listening to the facts presented by the city, we believe historic designation (if WW is successful in getting it) would help owners at WW. There seems to be little downside risk and quite a bit of potential upside if the historic status is approved.

Mary also shared that their realtors, Ray Wells and May Gonzalez of Sotheby's, 626-429-8290, have said that having historic status will enhance property values for homeowners. I too have been told this by realtors. People who are looking to live in Pasadena value history and value this kind of designation.

The Council will hear the nomination for WWA to be designated an historic landmark again this Monday, June 9 7:30 pm in the Council Chambers, City Hall, 100 N. Garfield Ave. I hope you can attend.

. I personally love the architecture of WWA and feel that it deserves to be recognized for the mid-century modern treasure that it is. And, I believe that there are lots of advantages to WWA having this designation -- many of which are pointed out in the information above.

Thanks for reading this, and I do hope you will support the designation.
