SUBJECT: AUTHORIZATION TO ENTER INTO CONTRACT WITH STANTEC CONSULTING INC. FOR UNDERGROUND CABLE ENGINEERING AND ANALYSIS FOR THE 34.5KV ELECTRIC TRANSMISSION SYSTEM FOR THE WATER AND POWER DEPARTMENT.

RECOMMENDATION:

It is recommended that the City Council:

- Accept the proposal dated August 25, 2008, from Stantec Consulting Inc. in response to the Water & Power Department's Request for Proposals for Underground Cable Engineering and Analysis dated August 5, 2008; reject all other proposals; and authorize a contract with Stantec Consulting, Inc. for one year or until \$200,000 is expended, whichever comes first, with one oneyear extension not to exceed \$200,000; and
- 2. Acknowledge that the proposed contract is exempt from competitive bidding pursuant to the City Charter Section 1002(F), contracts for professional or unique services.

BACKGROUND:

An assessment of the 34.5kV Electrical Distribution system performed by Imcorp, a cable testing company, earlier this year indicated that the system components are aging and that a replacement program is appropriate to ensure continuing reliable service. A replacement program is a prudent measure that will reduce the risk of cable failure and the amount of high-cost emergency work the Department would face as the cable system continues to age.

The City of Pasadena does not have available staff to develop an effective multi-year cable replacement program. A cable system-engineering consultant can provide the expertise required to perform studies and preliminary designs needed for a detailed replacement plan. Three firms, Stantec, Auriga and CLS, submitted proposals to the City in response to a Request for Proposals issued on August 5, 2008.

Technical Evaluation:

Proposals were evaluated based on multiple criteria as shown in Attachment 1. Total weighted scores were:

Vendor	<u>Score</u>
Stantec Consulting	8.45
Auriga	7
CLS	6

Stantec Consulting Inc. had the highest weighted score, and their proposal was responsive to the RFP, clearly indicating they have the experience and staff to do the required work in a timely manner, and their cost was within the engineer's estimate. In addition to their design expertise, they have experience working on the specific issues the Department is facing. The other two proposals reflected less expertise and experience. Investing in these engineering services now will help ensure a cost-effective and efficient cable replacement program.

The Department recommends approval of a contract with Stantec Consulting, Inc. for cable system design and analysis for one year or until \$200,000 has been expended, whichever comes first, with an option for one additional year not to exceed \$200,000.
