




**FISCAL IMPACT**

This ordinance was determined to be exempt from the requirements of the California Environmental Quality Act pursuant to State CEQA Guidelines Section 15378(b)(4).



**AN ORDINANCE OF THE CITY OF PASADENA AMENDING TITLE 4 OF THE PASADENA MUNICIPAL CODE TO UPDATE THE LIST OF PARKS AND OPEN SPACE AREAS ON WHICH RESIDENTIAL IMPACT FEES MAY BE EXPENDED (ROBINSON PARK)**

The People of the City of Pasadena ordain as follows:

**SECTION 1.** This ordinance, due to its length and corresponding cost of publication will be published by title and summary as permitted by Section 508 of the Pasadena City Charter. The approved summary of this ordinance is as follows:

**“SUMMARY**

Ordinance No. \_\_\_\_\_ will amend Title 4 of the Pasadena Municipal Code to update the list of parks and open spaces on which the residential impact fees may be expended, particularly to update the description of the recently expanded Robinson Park. A revised version of the Robinson Park map is attached to the full text of the ordinance and is on file in the City Clerk’s Office.

Ordinance No. \_\_\_\_\_ shall take effect upon publication.”

**SECTION 2.** Title 4, Chapter 4.17, Section 4.17.060, Subsection D of the Pasadena Municipal Code is amended to read:

“R. Robinson Park as depicted on Drawing No. 3576-R.”

**SECTION 3.** A revised version of the Robinson Park map is attached hereto and incorporated herein by reference.

**SECTION 4.** The City Clerk shall certify the adoption of this ordinance and shall cause this ordinance to be published by title and summary.

**SECTION 5.** This ordinance shall take effect upon publication.
