SUBJECT: AMENDMENTS TO ROBINSON PARK DRAWING

TITLE OF PROPOSED ORDINANCE

AN ORDINANCE OF THE CITY OF PASADENA AMENDING TITLE 4 OF THE PASADENA MUNICIPAL CODE TO UPDATE THE LIST OF PARKS AND OPEN SPACE AREAS ON WHICH RESIDENTIAL IMPACT FEES MAY BE EXPENDED (ROBINSON PARK)

PURPOSE OF ORDINANCE

This ordinance implements and codifies the amendments to Title 4 of the Municipal Code approved by the City Council on April 27, 2009. This legislation amends the drawing referenced in Title 4 of the Municipal Code regarding Robinson Park, to incorporate recent expansions at that park and to incorporate the Jackie Robinson Community Center into the Park.

REASON WHY LEGISLATION IS NEEDED

In order to spend residential impact fees on park improvements, the particular park must be identified in Title 4. Improvements envisioned at the new areas of Robinson Park and at Jackie Robinson Center are appropriately covered by residential impact fees. After amendment to the Robinson Park drawing, residential impact fees may be spent on improvements to the newly expanded portions of Robinson Park. No particular improvements are approved at this time.

PROGRAMS, DEPARTMENTS OR GROUPS AFFECTED

The Public Works Department will implement the proposed ordinance through construction of park improvements.


FISCAL IMPACT

There will not be an immediate fiscal impact as a result of this amendment to the Municipal Code.


ENVIRONMENTAL DETERMINATION

This ordinance was determined to be exempt from the requirements of the California Environmental Quality Act pursuant to State CEQA Guidelines Section 15378(b)(4).



AN ORDINANCE OF THE CITY OF PASADENA AMENDING TITLE 4 OF THE PASADENA MUNICIPAL CODE TO UPDATE THE LIST OF PARKS AND OPEN SPACE AREAS ON WHICH RESIDENTIAL IMPACT FEES MAY BE EXPENDED (ROBINSON PARK)

The People of the City of Pasadena ordain as follows:

SECTION 1. This ordinance, due to its length and corresponding cost of publication will be published by title and summary as permitted by Section 508 of the Pasadena City Charter. The approved summary of this ordinance is as follows:

“SUMMARY

Ordinance No. _____ will amend Title 4 of the Pasadena Municipal Code to update the list of parks and open spaces on which the residential impact fees may be expended, particularly to update the description of the recently expanded Robinson Park. A revised version of the Robinson Park map is attached to the full text of the ordinance and is on file in the City Clerk’s Office.

Ordinance No. _____ shall take effect upon publication.”

SECTION 2. Title 4, Chapter 4.17, Section 4.17.060, Subsection D of the Pasadena Municipal Code is amended to read:

“R. Robinson Park as depicted on Drawing No. 3576-R.”

SECTION 3. A revised version of the Robinson Park map is attached hereto and incorporated herein by reference.

SECTION 4. The City Clerk shall certify the adoption of this ordinance and shall cause this ordinance to be published by title and summary.

SECTION 5. This ordinance shall take effect upon publication.


