SUBJECT: ADOPTION OF TWO RESOLUTIONS FROM THE CALIFORNIA

DEPARTMENT OF FORESTRY AND FIRE PROTECTION'S URBAN FORESTRY GRANT PROGRAM FOR EDUCATION AND INVENTORY

PROJECTS

RECOMMENDATION:

It is recommended that the City Council:

- 1. Find that the actions proposed herein are exempt from the California Environmental Quality Act pursuant to State CEQA Guidelines Sections 15306 (information collection) and 15322 (educational or training programs involving no physical changes).
- 2. Adopt a resolution authorizing an application for the competitive Urban Forestry Education Grant program of 2008-2009 in the amount of \$91,000 to educate the public on the specific and direct benefits of trees in the urban environment, with a focus on sustainability; and
- 3. Adopt a resolution authorizing an application for the competitive Urban Forestry Inventory Grant program of 2008-2009 in the amount of \$200,000 to implement new software, data collection processes, and update information on the City's street tree canopy.

BACKGROUND:

The City of Pasadena has the opportunity to obtain grant funding from the California Department of Forestry and Fire Protection Urban Forestry Grant Program for the 2008-2009 funding cycle. The California Department of Forestry and Fire Protection has approximately \$1 million for the Urban Forestry Education grant program and \$1.5 million for the Urban Forestry Inventory grant program. The grant funds are provided from the Proposition 40, California Clean Water, Clean Air, Safe Neighborhood, Parks and Coastal Protection Act of 2002. Additional grant funds are provided from the Proposition 84, Safe Drinking Water, Water Quality and Supply, Flood Control, River and Coastal Protection Bond Act of 2006.

The Urban Forestry Education grant will allow the City to educate the public on the specific and direct benefits of trees in the urban environment, with a focus on sustainability by utilizing the City's urban forestry management plan, website, information pods, and television programs. The Urban Forestry Inventory grant will allow the City to implement new software, data collection processes, and update information on the City's street tree canopy.

On February 9, 2009, the City Council approved the original adoption of a resolution authorizing an application for the competitive Urban Forestry Education Grant program and the original adoption of a resolution authorizing an application for the competitive Urban Forestry Inventory Grant program. The City applied for the funding on October 24, 2008 but the release of the funding has been significantly delayed due to the State's budget issue. The original resolution stated that the City would expend grant funds prior to March 31, 2011. Due to the delay, the California Department of Forestry and Fire Protection Urban Forestry Grant Program staff is requesting the City to adopt new resolutions to indicate the grant funds would be expended prior to March 31, 2012.

FISCAL IMPACT:

If the City of Pasadena is successful in obtaining funding for the 2008-2009 funding cycle, the City will receive \$291,000 towards the City's Urban Forestry program. The City will be required to provide a total match of \$340,000 that will come from in-kind staff time and services and programs already in the FY 2009 operating budget for the Department of Public Works.
