

**AMENDMENT TO THE  
PREPAID NATURAL GAS PROGRAM,  
PROJECT 1, GAS SUPPLY AGREEMENT  
(City of Pasadena)**

THIS AMENDMENT TO THE PREPAID NATURAL GAS PROGRAM, PROJECT 1, GAS SUPPLY AGREEMENT (this "Amendment") is made and entered into effective as of December 1, 2009 (the "Amendment Effective Date"), by and between the City of Pasadena, a California municipality (the "Buyer"), and Southern California Public Power Authority, a joint powers agency and a public entity organized under the laws of the State of California ("SCPPA"). Each of Buyer and SCPPA may be referred to herein as a "Party," and collectively they may be referred to as the "Parties."

**RECITALS**

The Parties previously entered into that certain Prepaid Natural Gas Sales Program, Project 1, Gas Supply Agreement, dated October 3, 2007 (the "Gas Supply Agreement").

Goldman Sachs & Co. owns and has proposed to transfer to or for the account of SCPPA for surrender and cancellation of a portion of the Bonds in exchange for SCPPA's agreement with J. Aron, an affiliate of Goldman Sachs & Co., to reduce required gas deliveries under the Prepaid Gas Contract.

In connection therewith and for other mutually agreed purposes, the Parties desire to amend the Gas Supply Agreement as set forth herein.

Therefore, the Parties hereby agree, in consideration of the mutual premises and mutual obligations set forth herein, as follows:

**AGREEMENT**

Section 1. **Definitions.** Unless otherwise defined herein, capitalized terms used in this Amendment shall have the meanings ascribed to them in the Gas Supply Agreement. The definitions of "Primary Delivery Point" and "Monthly Index Price" in Appendix A to the Gas Supply Agreement are hereby amended by substituting "Appendix" for "Exhibit" in each place such latter word appears in such definition.

Section 2. **Amendments.**

(a) Delivery Point.

(i) With effect from the Amendment Effective Date through the end of the term of the Gas Supply Agreement, but subject in all cases subject to Section 2(a)(ii) below, Appendix D-1 of the Gas Supply Agreement is hereby replaced in its entirety by Appendix D-1 attached hereto as Schedule 1.

(ii) Buyer acknowledges that if Seller receives a notice of a Physical Premium Differential under (and as defined in) the Prepaid Gas Contract, Seller must, pursuant to the terms of the Prepaid Gas Contract, elect one of the following two options with respect to the Prepaid Gas Contract within 270 days after Seller's receipt of such notice: (A) pay the Physical Premium Differential with respect to the Prepaid Gas Contract (the "Physical Premium Option") or (B) revert the Primary Delivery Point (and the corresponding index prices associated with such delivery point) for the Prepaid Gas Contract to the Border Delivery Point (as defined in the Prepaid Gas Contract) (the "Delivery Point Reversion Option"). If Seller fails to make an election, Seller will be deemed to have elected the Delivery Point Reversion Option.

(iii) In connection with any notice of Physical Premium Differential Seller receives as described in clause (ii) above, Seller agrees to promptly provide a copy of such notice to Buyer and, within 265 days after Seller's receipt of such notice, Buyer will irrevocably notify Seller in writing of Buyer's preference for Seller to elect either the Physical Premium Option or the Delivery Point Reversion Option. If Buyer provides notice preferring the Physical Premium Option before the deadline expressed in the preceding sentence, Seller will elect the Physical Premium Option under the Prepaid Gas Contract. In all other cases, Seller will elect (or will allow a deemed election to be made for) the Delivery Point Reversion Option under the Prepaid Gas Contract.

(iv) The effect of Seller's election as described in clause (ii) above shall be as follows:

(A) If Seller elects the Physical Premium Option under the Prepaid Gas Contract, Buyer will pay the Physical Premium Differential to Seller on a monthly basis for all Gas that is delivered to Buyer (including for make up deliveries of Gas pursuant to Section 4.3) under the Gas Supply Agreement on or after the Option Effective Date through the end of the term of the Gas Supply Agreement in addition to other amounts payable hereunder for such Gas; or

(B) If Seller elects or is deemed to have elected the Delivery Point Reversion Option under the Prepaid Gas Contract, Appendix D-1 of the Gas Supply Agreement will revert to Appendix D-1 as in effect immediately prior to the Amendment Effective Date with such reversion effective as the Option Effective Date. If any index price set forth on Appendix D-1 as in effect immediately prior to the Amendment Effective Date is no longer reported at the time of such reversion described in the immediately preceding sentence, such index price shall automatically be deemed to conform to the corresponding index price in the Prepaid Gas Contract.

(b) Daily Contract Quantities.

(i) The definition of "Daily Contract Quantity" in the Gas Supply Agreement is hereby amended and restated to read as follows:

*"Daily Contract Quantity"* means, with respect to each Gas Day during the Delivery Period and each Delivery Point, the quantity of Gas (in MMBtu) shown on *Appendix D-2* under the name of the Buyer for such Delivery Point opposite the Month in which such Gas Day occurs divided by the corresponding number of days in such Month.

(ii) Appendix D-2 of the Gas Supply Agreement is hereby replaced in its entirety by the two columns in the Appendix D-2 attached hereto as Schedule 2 headed "Month" and with the name of Buyer.

(c) Delivery Period. The Parties agree to amend and restate Section 2.2 of the Gas Supply Agreement as follows:

"The delivery period under this Agreement (the *"Delivery Period"*) commenced at the beginning of the Gas Day that commenced at 7:00 a.m. PPT on July 1, 2008, and shall continue in effect until the end of the Gas Day that commences at 7:00 a.m. PPT on September 30, 2035, or earlier, on the Early Termination Date."

Section 3. **Representations and Warranties.** Each of the Parties hereby makes each of the representations and warranties, as applicable, set forth in Article VIII of the Gas Supply Agreement to the other Party as of the Amendment Effective Date, to the same effect as if each reference to the Gas Supply Agreement therein were to this Amendment and to the Gas Supply Agreement as amended by this Amendment, except that the representations in Section 8.1(d) of the Gas Supply Agreement are qualified to the extent that the execution and delivery of this Amendment may require an approval or consent of persons which has heretofore been received.

Section 4. **Entire Agreement.**

Except as hereby expressly modified, all terms of the Gas Supply Agreement remain in full force and effect. This Amendment: (i) shall bind and benefit the Parties and their respective successors and assigns; (ii) shall be modified or amended only in the manner set forth in the Gas Supply Agreement; and (iii) embodies the entire agreement and understanding between the Parties.

Section 5. **Counterparts.** This Amendment may be executed in counterparts, each of which is deemed an original.

**Appendix D-1: Primary Delivery Points**

THROUGHOUT THE TERM OF THIS AGREEMENT, AND NOTWITHSTANDING ANY OTHER INCONSISTENT PROVISION IN THIS AGREEMENT, THE TERMS AND CONDITIONS RELATIVE TO DELIVERY POINTS SET FORTH IN THE PREPAID GAS CONTRACT SHALL CONTROL OVER THE TERMS AND CONDITIONS RELATIVE TO DELIVERY POINTS SET FORTH IN THIS AGREEMENT AND THE DELIVERY POINTS SPECIFIED FOR BUYER IN THIS AGREEMENT SHALL BE THE SAME DELIVERY POINTS AS THE DELIVERY POINTS SPECIFIED FOR BUYER IN THE PREPAID GAS CONTRACT.

\* Buyer shall have the right to nominate the relevant End-User Local Transportation Agreement or Citygate Pool Account to be used on reasonable notice given to Seller prior to the relevant scheduling deadlines applicable to the SoCal System. The terms "End-User's Local Transportation Agreement" and "Citygate Pool Account" are defined in the rules issued by the operator of the SoCal System with respect to deliveries on the SoCal System and refer to delivery location designations for Gas to be delivered within the SoCal System. If either such delivery location designation is redefined or replaced in any modification to such rules, then, for purposes of the definition of Primary Delivery Point, the most closely analogous delivery location designation in the rules as modified shall apply. If, at any time, Gas Supplier is required to pay any charges or fees to deliver from Gas Supplier's pool account on the SoCal System to any delivery location designated by Buyer and invoices Seller for such charges under the terms of the Prepaid Gas Contract, such charges shall be for Buyer's account and Seller may invoice Buyer for such charges on a monthly basis.
