**SUBJECT:** AN ORDINANCE OF THE CITY OF PASADENA SUSPENDING SECTION 3.24.090 OF THE PASADENA MUNICIPAL FOR A PERMITTED EVENT AT HAHAMONGNA PARK FOR SPECIFIED HOURS ON SUNDAY, MAY 16, 2010 (MIKE ANTONOVICH TRAIL RIDE).

**TITLE OF THE PROPOSED ORDINANCE:**

AN ORDINANCE OF THE CITY OF PASADENA SUSPENDING SECTION 3.24.090 OF THE PASADENA MUNICIPAL CODE RELATING TO ALCOHOL SERVICE FOR A PERMITTED EVENT AT HAHAMONGNA WATERSHED PARK FOR SPECIFIED HOURS ON SUNDAY, MAY 16, 2010.

**PURPOSE OF ORDINANCE:**

This proposed ordinance is to suspend section 3.24.090 of the Civic Events & Facilities Ordinance to allow alcohol service for a permitted event at Hahamongna Watershed Park on Sunday, May 16, 2010 from 6:30 a.m. to 5:00 p.m. This is a Los Angeles County event, i.e., Mike Antonovich Trail Ride. The enactment of this proposed ordinance is needed to suspend the prohibition against alcohol service in the referenced park.

**REASON WHY LEGISLATION IS NEEDED:**

The Civic Events & Facilities Ordinance was enacted by ordinance and can only be suspended by an ordinance of the City Council.

**FISCAL IMPLICATIONS:**

There are negligible fiscal impacts and any costs that may be incurred, (e.g. event monitoring, permit costs, park clean-up, etc.) are to be paid by the promoter.


**ENVIRONMENTAL IMPACT:**

SECTION 2. The City Clerk shall certify the adoption of this ordinance and shall cause this ordinance to be published in full text.

SECTION 3. This ordinance shall take effect upon its publication.
