The Mayor announced that public comment had been completed, and there would be no further public comment on matters not on the agenda.

CONSENT ITEM DISCUSSED SEPARATELY

EXTENSION OF PASADENA JOB CENTER LEASE AT 500 NORTH LAKE AVENUE, CONTRACT NO. 17,188 Recommendation:

(1) Find that the leasing of the Pasadena Job Center located at 500 North Lake Avenue from TOVA, LLC (TOVA) is categorically exempt from the California Environmental Quality Act (CEQA), pursuant to State CEQA Guidelines, Section 15301 (Existing Facilities); and

(2) Authorize the City Manager to execute a five-year lease incorporating the terms and conditions generally described in the agenda report with TOVA, for the City to continue leasing the building located at 500 North Lake Avenue for a day labor operations facility (Job Center), and any other documents necessary to carry out the lease. (Agreement No. 20,222)

Councilmember McAustin expressed concerns regarding extending the lease (whether this is the appropriate location, addresses the loitering issues in neighborhoods, and whether the increased lease amount provides an adequate public benefit for the costs incurred).

The City Manager commented on the benefit of the services provided by the Pasadena Job Center, and indicated that staff was continuing to work on issues related to the operations agreement for the Center.

Councilmember Madison arrived at 6:44 p.m.

Steve Mermell, Assistant City Manager, indicated that usage information for the Center would be provided to Council in the City Manager's weekly newsletter.

Kelly Kitasato, Real Property Manager, reviewed alternative sites that had been explored for the job center as part of a Power Point presentation.

Councilmember Holden noted that an alternative site would not be approved without notification to the public and an opportunity for public comment on any proposed change in location.

Vice Mayor Gordo described the various services provided by the Pasadena Job Center, and noted that enforcement issues related to the loitering in neighborhoods needed to be addressed separately.

Following discussion, it was moved by Vice Mayor Gordo, seconded by Councilmember Robinson, to approve the staff recommendation. (Motion carried, with Councilmember McAustin objecting) (Absent: Councilmember Haderlein)

INFORMATION ITEM

Vice Mayor Gordo was excused at 6:58 p.m.

CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA): WORKSHOP FOR COUNCIL

Recommendation: No formal action is required by the City Council. The workshop is to provide a general overview of CEQA and Environmental Impact Reports (EIR), allowing for Council discussion and questions.

The Mayor introduced the agenda item.

Theresa Fuentes, Assistant City Attorney, reviewed the agenda report as part of a PowerPoint presentation, invited Council to attend two California Environmental Quality Act (CEQA) seminars that will be provided by the City Attorney's Office in the summer of 2010, and responded to questions.

The City Manager discussed existing thresholds of significance, noted that staff was exploring how to separate the CEQA process from the Council's approval/entitlement process when projects are presented to Council in the future, and responded to questions.

The City Attorney responded to questions regarding the relationship between the CEQA certification process and the project approval process.

Jennifer Paige-Saeki, Senior Planner, indicated that the public notice of a project contains a CEQA notification and that the public also has access to environmental notices that are posted on the Planning and Development Department's web site.

Discussion followed on the process to determine if an Environmental Impact Report (EIR) is necessary; issues/scenarios involving thresholds of significance, setting a baseline, cumulative impacts, alternatives, land use issues,

findings, and statements of overriding consideration (SOC); differences between a plan EIR vs. project EIR; the need to provide a mechanism that clearly separates Council's CEQA certification action from the project approval action when a project is considered; use of mitigation measures to shape a project; the legal standard of CEQA review; and the roles of the City Attorney's staff and other departments' staff, consultants, and the public in the CEQA process.

Councilmembers stressed the need to more clearly define the two separate Council actions: (1) CEQA certification, and (2) project approval.

Richard McDonald, Planning Commission Chair speaking as an individual, made the following suggestions for Council consideration: direct the General Plan Update Advisory Committee (GPUAC) and staff to include the thresholds of significance, especially as it applies to traffic, in the Mobility Element update; make plan EIRs more specific in their analysis than they have been in the past; replace Supplement to Master Application Environmental Assessment form with Initial Study form (to be filled out and submitted by applicant); include Initial Study (as submitted by applicant and revised by City staff) as part of the Predevelopment Plan Review presentation to Council; and move to front-loading the environmental information into the project review/approval process.

Councilmember Holden suggested staff develop a case study of a project that has been built and would show how a project may evolve as part of the EIR process, and provide Council with information on the thresholds of significance that are being used by staff in the CEQA process.

Ms. Fuentes indicated that staff could prepare a case study to illustrate the development of a project under the CEQA process (e.g., basic project objectives, reduction of environmental effects, and alternatives).

Councilmember McAustin suggested staff explore an internetbased application that would provide a mechanism for the public to submit their comments on environmental impact issues of a project and the staff to respond to these public comments.

Councilmember Tornek stated his opinion that agenda reports need to include information that more fully sets out both sides of the issues raised about a proposed project when it is presented for approval by Council; and suggested staff explore a fuller presentation of alternatives for a project, which could provide a more complete analysis of the project and assist Council in its decision-making role.

The Mayor noted that it was at the City Manager's suggestion that informational workshops be held for Council, which had resulted in the scheduling of this CEQA workshop. The Mayor suggested that Council consider a future workshop on the land use entitlement process and how policies, practices, procedures, motions, and resolutions are brought to bear in shaping a project so that the Council can be assured that the project conforms to the intentions of the Council before it is presented for approval.

On order of the Mayor, the report was received and filed.
