CANVASS OF THE APRIL 19, 2011 GENERAL MUNICIPAL ELECTION

## **RECOMMENDATION:**

It is recommended that the City Council:

- (1) Accept the Certificate of Canvass.
- (2) Adopt a resolution declaring that Gene Masuda is elected to the office of member of the City Council, District 4.

### **BACKGROUND:**

MEETING OF

The City of Pasadena held its Primary Nominating Election on Tuesday, March 8, 2011, for the Office of Mayor and members of the City Council, Districts 1, 2, 4, and 6. Pasadena City Charter, Section 1204, provides that, "Any person who, at the primary election, shall receive a majority of the total votes cast for candidates for said office shall be elected to such office."

At the March 8, 2011 Primary Nominating Election, Bill Bogaard, Mayoral Candidate, Jacque Robinson, City Council District 1 candidate, Margaret McAustin, City Council District 2 candidate, and Steve Madison, City Council District 6 candidate, all received a majority of the votes cast and were re-elected for their respective offices.

In the Council District 4 race, of five candidates running for this office, no one received a majority of the total votes cast. Candidates Gene Masuda and Jill Fosselman received the highest number of votes cast for District 4. In accordance with the Pasadena City Charter, Section 1204, the two candidates with the highest number of votes cast for the respective office had their names placed on the ballot for the General Municipal Election held on April 19, 2011.

The final tally of the votes cast at the April 19, 2011 General Municipal Election is as follows:

Gene Masuda 2,081 - 55.6% District 4
Jill Fosselman 1,657 - 44.3% District 4

Gene Masuda, City Council District 4 candidate, received a majority of the votes cast and is elected as member of the City Council, District 4.

### **FISCAL IMPACT:**

The total cost of this election will be shared pro rata by the Pasadena Unified School District (PUSD) and the City, since there was a run-off election for PUSD Board of Education, Seat 6. The final amount will be tabulated upon receipt of all invoices, and the School District will be invoiced by the City for its pro rata share of costs, based on a formula to be established by the Los Angeles County Registrar of Voters Office. Sufficient funds are available in the City Clerk's FY 2010-2011 Election Budget to cover the City's portion of election expenses.
