SUBJECT: AUTHORIZATION TO AMEND THE PASADENA MUNICIPAL CODE AS NEEDED TO ENACT THE APPROVED PARKING RELATED CHANGES TO THE GENERAL FEE SCHEDULE

RECOMMENDATION:

It is recommended that the City Council:

1. Find that the following proposed actions are exempt from review pursuant to the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 15061 (b) (3); and
2. Direct the City Attorney to prepare an ordinance amending the Pasadena Municipal Code to enact the City Council approved parking related changes to the General Fee Schedule for Fiscal Year 2013.

BACKGROUND:

On June 4, 2012, City Council approved a number of additions and modifications to the General Fee Schedule related to parking in Pasadena. The fees noted below require amendments to the Pasadena Municipal Code (PMC) before taking effect. The amendments are of three general types:

1. Replacement of references to Finance Director and Public Works Director with Transportation Director (where appropriate)
2. Replacement of "fee for issuance" with "fee for application"
3. Add the authority to collect a fee (where appropriate).

ENVIRONMENTAL ANALYSIS:


The requisite Pasadena Municipal Code amendments are categorically exempt from the California Environmental Quality Act (CEQA) under section 15061 (b) (3), the General

FISCAL IMPACT:


