In addition to the efficiencies outlined above, the Department of Public Works is reviewing every facet of the Integrated Waste Management Section's operations for additional opportunities. For example, staff has identified the two major initiatives explained below.

1. This summer the Integrated Waste Management Section in cooperation with the Public Information Officer will initiate a public education campaign for the residential pay-as-you-throw or variable rate program. The purposes of the campaign:
 - Let residential customers know they can reduce their refuse bills by generating less mixed waste and reducing the size of the mixed waste container used;
 - Encourage residential customers to recycle by making them aware that the City offers additional recycling and green waste containers at no cost; and
 - Reduce the Integrated Waste Management Section's operational costs and increase recycling revenue. If every residential customer generates 50% less mixed waste and places that 50% into the recycling container, the City may realize savings and revenue generation equivalent to \$1 million annually.
2. After July 1, 2012, the effective date of AB 341, which requires businesses, commercial properties, and multi-family properties consisting of 5 or more units to recycle on site or have a service provider that provides recycling collection and increases the statewide diversion goal to 75% by 2020, the Department of Public Works will comprehensively review its commercial refuse collection operation. The department will pursue opportunities for efficiencies and cost savings, as well as determine how best the City should compete in the new commercial environment created by AB 341.
