TRANSCORE ORGANIZATIONAL STRUCTURE

Roper Industries, Inc. (a NYSE company with a market equity capitalization in excess of \$4 billion) was incorporated 12/17/81 in the state of Delaware as Dexter Industries, Inc. The name was officially changed to Roper Industries on 06/29/82. Roper Industries, Inc. acquired TransCore Holdings, Inc. and its subsidiary companies on 12/13/04.

TransCore Holdings, Inc. was incorporated 9/3/99 in the state of Delaware (following the divestiture of SAIC on this date), and is the parent company of TLP Holdings, LLC and TransCore Partners, LLC. TransCore Holdings, Inc. became a wholly owned subsidiary of Roper Industries, Inc. when it was acquired by Roper on 12/13/04.

TransCore Partners, LLC was incorporated 12/01/87 in the state of Delaware as AMGT Corporation. On 08/13/01, the name was officially changed to TransCore Partners Inc. On 07/31/05, the corporation underwent a legal business entity conversion from a corporation to a limited liability company (the FEIN did not change). TransCore Partners, LLC is the limited partner of TransCore, LP (98.864% ownership).

TLP Holdings, LLC was incorporated 8/13/2001 in the state of Delaware and is the general partner of TransCore, LP (1.136% ownership).

FEIN No.: 25-1894329

TransCore, LP was incorporated 3/3/94 in the state of Delaware under the name Syntonic Technology, Inc. On 11/15/99, the name was officially changed to TransCore, Inc. On 9/10/01, TransCore, Inc. underwent a legal business entity conversion from a corporation to a limited partnership (the FEIN number remained unchanged). TLP Holdings, LLC and TransCore Partners, LLC manage TransCore, LP. TransCore, LP is the limited partner of Viastar Services, LP (99% ownership). Also note that TC (Bermuda) Finance, LTD (incorporated in the Islands of Bermuda on 10/24/2001, FEIN No.: 98-0355546) was domesticated and rolled into TransCore, LP on 11/30/04.

TransCore, Inc. completed its acquisition of Amtech Systems, a division of Intermecc Technologies Corp., a UNOVA Inc. company on 06/30/00.

TransCore ITS, LLC (formerly JHK & Associates, JHK & Associates, Inc., d/b/a TransCore and subsequently TransCore ITS, Inc.) was incorporated 1/21/94 as "JHK Acquisition Corporation" in the state of Delaware. On 4/8/94, "JHK & Associates" (a California company) merged with and into "JHK Acquisition Corporation" to form "JHK & Associates, Inc." On 2/2/00, the name was officially changed to TransCore ITS, Inc. On 09/30/05, the corporation underwent a legal business entity conversion to a limited liability company (the FEIN did not change), and the name changed to TransCore ITS, LLC. TransCore ITS, LLC is a wholly owned subsidiary of TransCore, LP. JHK & Associates was incorporated on 06/02/71 in California, and the FEIN was 94-1745398 (although no "official" supporting documentation exists to substantiate this).
