Were you looking forward to the weekend and taking a leisurely walk around the Rose Bowl with your dog or maybe a more ambitious run or bike ride? Maybe you wanted to take the children to Kidspace or go for a swim at the Rose Bowl Aquatics Center. If you were thinking about moving to Pasadena, these are positives to consider, but if you already live in Pasadena, you know the reality isn't quite so ideal. You know after living here that access to the Central Arroyo Seco is frequently limited and parking can be worse than any where on the Westside.

The parking and access is not just a problem on those six or seven Saturdays a year when UCLA plays their home football games at the Rose Bowl. There's also the actual Rose Bowl game and the week before New Year's with all the parade-related events. Then there is the relatively new Pasadena Marathon and the 4<sup>th</sup> of July show. Let's also not forget the monthly flea market. With the other numerous events – annual weekend dog show, food truck festival, soccer tournaments, and charity walks- that occur over the weekends, regular users of the amenities in the area encounter some kind of disruption for nearly half of the 52 weekends a year. There's no doubt these events bring the city a much needed increase in revenue from its visitors, but this is at the cost of the residents who have made this place their home and cannot enjoy it to the extent one would hope on the weekends. Residents bring revenue into the city too, but it has now become an us-or-them situation.

This year there are several games that start at 12:30 PM and the RBAC is closed at 8:00 or 8:30 AM. I suppose I could get there at the 6:00 AM opening time, but would you want to? I read the "closing at 8:30AM" and think "so people can get tailgate and get drunk by noon." I don't think this is the type of activity that should win over anything else positive that can go on around the complex. Parking is protected when there is tailgating involved, but not when families come for swim lessons or runners congregate for Team-in-Training. In lieu of late game starts, I think the city should consider imposing sacred hours. For example, how about if swimmers and other regular, organized users of the facilities could enter with official parking passes before 10AM and be allowed to stay til noon. We would be in Lot I at the furthest end from the stadium itself and close to the exits taking us out of the Arroyo Seco. And, we would not be getting drunk at that sacred hour either.

It seems probable that some percentage of the fees for the football games and other events are already allocated to providing day-of services, so why not implement consistent traffic and parking regulations in the streets and lots? Most of my experience and frustrations stem from being a long-time swimmer at the Rose Bowl Aquatics Center (RBAC). A few years I had a momentary glimmer of hope that parking regulation was going to improve when "RBAC" was painted on many rows of parking spots. Since then things seem to have gotten worse. When there are special events, there seems to be no consistent plan in place. Sometimes there are barricades, and sometimes there are not. Sometimes someone is monitoring the parking entrances. Sometimes no one is. Sometimes it's a lifeguard from the aquatics center. Sometimes it's someone hired to do the job.

What you encounter on an event day is unpredictable, but you know it will be a mess. Until things change, how do you survive the parking lot on an event day? It's much like shopping at the mall the week before Christmas. First decide what kind of driver you want to be. You can be a squatter, waiting for someone within a three car range to show up to leave or you can be a stalker, slowly driving through the lanes until you find someone to creep behind all the way back to his or her car and hope there is no squatter already there. Either way you have some unusual navigating to do to get to that parking spot. Drivers often times park in the driving lanes right next to the last marked spot in a row. This happens at both ends, so even though there might be barricades to delineate the two driving lanes, inevitably one is lost to parked cars. The outer perimeter becomes a one-way road, but that does not mean all the drivers are going the same way. So when you see a car coming at you in the opposite direction you can't be surprised. You then go down a row of parking spots, all taken, no one to stalk, and then you hit another barricade. You can't go forward any more, because another barricade has created a dead end forcing you to make a u-turn where on a normal day you would have the choice of turning left or right, something that suddenly seems like a luxury. You get out by making a 50-point turn in this spacious two-lane row, make it out back into the one-lane outer perimeter and quickly dart over to another cul-de-sac of parking spots to carry on with your stalking or squatting. Finding a parking spot can easily take 15 or 20 minutes, precious minutes stolen from the workout you came to do in the first place.

This battle is better fought as a team. I envy the parents arriving for their children's swim classes. One parent can get dropped off with the child while the other continues to drive around the lot. The chaos of cars being driven where they can, not where they should, heightens the dangers of walking a child across the parking lot. The barricades should be a measure of safety, but in this circumstance they exacerbate the danger in the lot. And should an accident occur requiring first responders, I'm not confident that an ambulance or fire truck would manage to get from the parking entrance to the site in a timely manner. This alone warrants increasing safety with a better command of event day parking.

Having a huge stadium nestled amongst homes and a variety of park facilities seems odd to begin with. Then add the complication of narrow roads leading into and out of the Central Arroyo. Trying to accommodate visitors and residents doesn't sound easy, but seems manageable with some further coordination beyond what is going on now. I'm not claiming to know the rules and regulations that have brought the city's use of the Rose Bowl and surrounding facilities to an us-versus them state. I just want to point out that there are problems that seem to have gotten worse over the years, and some better organization might makes things more accessible and safe for everyone. Finances are obviously being allocated for some things, so why not allocate some percent of the revenue generated by the special events to things that work. Strategically-placed barricades and professional monitoring can only decrease the driving and parking violations and increase the safety and access of the lots and use of the facilities by the locals. Why not make it so residents can enjoy the Rose Bowl along with visitors?
