**SUBJECT: ADOPT A RESOLUTION AUTHORIZING THE CHIEF OF POLICE TO DESTROY INTERNAL AFFAIRS FILES REGARDING INVESTIGATIONS AND NON-HIRE BACKGROUND FILES**

## **RECOMMENDATION:**

It is recommended that the City Council adopt a resolution authorizing the Chief of Police, with concurrence of the City Attorney, to destroy internal affairs investigation files concluded from 1997 through 2007, which are listed in Attachment-A, as well as non-hire background files completed from 1998 through 2007 - Attachment-B.

## **BACKGROUND:**

Government Code § 34090 requires that the City Council approve by resolution the destruction of Police Department internal affairs investigation files. Evidence Code § 1045 requires that such files only be kept for five years. The designated files contain investigations that have been adjudicated.

Government Code § 34090 requires that the City Council approve by resolution the destruction of completed non-hire background files. The Government Code requires that non-hire background files be kept for a minimum of two years. The City Attorney's Office has recommended that background files be kept for a minimum of five-years for purposes of any unforeseen litigation. The designated files are not involved in any litigation.

In accordance with the law, it is common practice for police agencies to periodically purge dated internal affairs investigation files and to periodically purge dated, closed and completed background files.

The Chief of Police and the City Attorney have reviewed the affected files to assure that no pending matters are involved and that no prejudice will result from the destruction of these files.

**COUNCIL POLICY CONSIDERATION:**

The adoption of this resolution is consistent with the City Council's Green Initiative and the City Council Goal to increase conservation and sustainability.

**ENVIRONMENTAL ANALYSIS:**

This action is exempt from CEQA pursuant to Article 19, Categorical Exemptions section 15300.


**FISCAL IMPACT:**

RESOLUTION No.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASADENA AUTHORIZING THE POLICE CHIEF TO DESTROY DESIGNATED RECORDS MAINTAINED BY THE PASADENA POLICE DEPARTMENT

WHEREAS, Government Code section 34090 requires that the City Council authorize by resolution the destruction of certain types of records maintained by the City of Pasadena, including records of internal affairs investigations conducted by the Police Department which are not required to be maintained by law; and

WHEREAS, the Police Department seeks to destroy records of internal affairs investigation concluded from 1998 through 2007 which are listed in Attachment-A and non-hire closed and completed background files concluded from 2002 through 2006 which are listed in Attachment-B because of lack of controlled confidential storage space for those records, which are required to be retained only for five years; and,

WHEREAS, the Police Chief and the City Attorney have reviewed the list of records to be destroyed and have determined that such records may lawfully be destroyed without prejudice to the City or to any other person;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pasadena as follows:

1. The Police Chief is authorized to destroy the designated records of internal affairs investigations concluded from 1998 through 2007 which are listed in Attachment-A.
2. The Police Chief is authorized to destroy the designated records of non-hire background files concluded from 2002 through 2006 which are listed in Attachment-B.
3. Such destruction of records shall be carried out in a manner which assures that the confidentiality of those records will not be breached.
