The Downtown Pasadena Neighborhood Association ("DPNA") enthusiastically supports the initiative to reconfigure a portion of Colorado Boulevard in order to introduce parklets in the Playhouse District.

Colorado Boulevard increasingly functions as a <u>destination</u>, as a place around which community life congregates and new businesses locate. Overall quality of life, citizen health, and economic vitality of businesses will be significantly enhanced with greater emphasis on Colorado Boulevard as a destination for all activities and de-emphasis of its use primarily for facilitating movement of cars.

Colorado Boulevard is now *less* about getting people from one end of the city to the other, and *more* about being the gathering point for theatre, dining, shopping, business, living, and recreation.

We believe that these activities will be greatly enhanced via the "Parklets, Plus" initiative because:

- The reduction of travel lanes from 5 to 3 will reduce the noise created by speeding cars. This noise hinders sidewalk activity and street life in general by muffling conversation and creating a perception of danger. We anticipate that it will be even more pleasant to dine 'al fresco' or stroll on the sidewalk when traffic noise is reduced.
- The angled parking will further calm traffic and provide additional on-street spaces.
- The parklets will provide interesting diversions that stimulate social vibrancy and create a better community gathering place. This will also further the Playhouse District's creation of a unique sense of "place" separate but connected to Old Pasadena that will further stimulate local commerce and economic development.
- The newly configured roadway will serve to calm traffic 24 hours a day, thereby improving safety for vulnerable road users such as pedestrians, children and the elderly.

As it currently stands, the road configuration along this stretch of Colorado Boulevard is a <u>valuable</u> <u>asset</u> that sits mostly empty and/or under-utilized for much of the day. The "Parklets, Plus" initiative

Day One's mission is to build healthy, vibrant communities by advancing public health, empowering youth and igniting change. The *Parklets, Plus* initiative touches upon several of these goals, and is worthy of piloting to better understand its potential positive impacts on the community.

#### Parklets, Public Health and Roadway Safety

After decades of auto-centric transportation and land-use planning, short car trips have become a major source of air pollution, emissions, traffic congestion, and fuel consumption in Los Angeles County. The sedentary lifestyles that have also resulted from our automobile-focused transportation and land-use planning have also enacted a severe toll on the health and well-being of our communities. Indeed, rates of childhood obesity and other weight related illnesses are far too high, especially among minority populations.

Fortunately there is latent potential for greater utilization of forms of healthy, active transportation in our City, especially if we can make our downtown district safe, comfortable and easily-accessible for pedestrians, bicyclists and transit users. Indeed, 50-75% of automobile trips - approximately 50% of commuting and 75% of shopping - are less than five miles in length, distances easily covered by foot and/or bicycle. If the City tackles this remaining barrier via the future implementation of protected bicycle infrastructure, traffic calming measures, and a planned Metro Bike Share program in downtown Pasadena, forms of sustainable, healthy transportation such as bicycling will become a viable alternative to local residents and visitors.

The proposed *Parklets, Plus* pilot would be a step in this direction by calming traffic, shortening crossing distances for pedestrians, utilizing reverse-angled parking (which is significantly safer than standard vertical parking by providing better sightlines for motorists exiting parking stalls), creating more public space, and developing a more vibrant central district.

Day One hopes you as local leaders will support the proposed pilot project.
