**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASADENA
ADOPTING A DECLARATION OF LANDMARK DESIGNATION OF THE
HOUSE AT 2350 EAST ORANGE GROVE BOULEVARD, PASADENA,
CALIFORNIA**

WHEREAS, the City Council has found that the house at 2350 East Orange Grove Boulevard meets criterion "C", as set forth in Section 17.62.040(C) of the Pasadena Municipal Code; and

WHEREAS, the house at 2350 East Orange Grove Boulevard is significant because it embodies the distinctive characteristics of a historic resource property type, period, architectural style or method of construction, or represents the work of an architect, designer, engineer, or builder whose work is significant to the City or to the region, or that possesses high artistic values that are significant to the City or to the region;

WHEREAS, the application for Landmark designation is exempt from the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines Section 15308;

WHEREAS, the property owners, Don Heida & George Dockter, submitted the application for landmark designation; and

WHEREAS, the City Council may designate a Landmark and evidence such approval by adopting a declaration executed by the Mayor pursuant to Subsection 17.62.050 (C) of the Pasadena Municipal Code;

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Pasadena that the attached declaration of Landmark designation for the house at 2350 East Orange Grove Boulevard is hereby adopted.



DECLARATION OF LANDMARK DESIGNATION FOR:

2350 East Orange Grove Boulevard
PASADENA, CALIFORNIA

Pursuant to the provisions of Section 17.62.050 of the Pasadena Municipal Code, the City Council of the City of Pasadena by this declaration hereby designates as a Landmark certain real property described as:

The east 30.95 feet of Lot 6, all of Lot 7 and the west 14.05 feet of Lot 8, Block "G", Tract No. 8825, in the City of Pasadena, County of Los Angeles, State of California, as per map recorded in Book 112, Pages 82 to 84 inclusive of Maps, in the office of the County Recorder of said County.

Under Pasadena Municipal Code Section 17.62.090, all work affecting designated Landmarks, except ordinary maintenance and repair, such as but not limited to new construction and additions, exterior alterations, relocation, and demolition, is subject to review by the City of Pasadena.
