Dear Neighbors:

This coming Monday, October 27th, the City Council will hear a proposal from the Department of Transportation that would change the rules for residents who live on time limited parking streets. Residents would be entitled to get annual daytime parking permits and annual daytime guest parking permits that would enable them to park in restricted parking areas and exceed the posted time limits without getting a parking ticket. The annual fee for the initial pack of permits would be \$10.00.

The proposal would alleviate two problems that we hear frequently from you: it would enable residents who live on time restricted streets to host guests without purchasing a daily permit for them, and it would enable residents to come and go throughout the day while parking on their street.

These changes are in response to many of your complaints, and we hope that if you are in favor of this proposal, you will communicate your support to the Mayor and City Council before the meeting on Monday evening. There may be some resistance from the Council to approve this measure, because the proposal may "reduce parking citation revenue to the General Fund by as much as \$470,000 annually." I think the goodwill generated by this proposal would make Pasadena a more desirable place to live and work, leading to increasing property values and other city benefits.

While I'm on the subject of parking citations, I should mention that the aggressive enforcement of parking citations throughout our city (eg, ticketing cars immediately after their meters expire) is bad for business in Pasadena and makes us an unfriendly place for visitors. 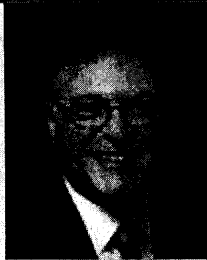



For our second car we purchase yearly day time and night time parking permits. We have no problem with the cost of purchasing these permits each year.
