**AN ORDINANCE OF THE CITY OF PASADENA AMENDING TITLES 3 AND 4 OF THE PASADENA MUNICIPAL CODE TO UPDATE THE LIST OF PARKS AND OPEN SPACE AREAS ON WHICH RESIDENTIAL IMPACT FEES MAY BE EXPENDED (DESIDERIO NEIGHBORHOOD PARK)**

The People of the City of Pasadena ordain as follows:

**SECTION 1.** This ordinance, due to its length and corresponding cost of publication will be published by title and summary as permitted by Section 508 of the Pasadena City Charter. The approved summary of this ordinance is as follows:

**“SUMMARY**

Ordinance No. \_\_\_\_\_ will amend Titles 3 and 4 of the Pasadena Municipal Code to add Desiderio Neighborhood Park to the list of dedicated parks and open spaces, particularly those on which the residential impact fees may be expended and include Desiderio Neighborhood Park. A copy of the Desiderio Neighborhood Park map (Drawing No. 6181) is attached to the full text of the ordinance and is on file in the City Clerk’s Office.

Ordinance No. \_\_\_\_\_ shall take effect upon publication.”

**SECTION 2.** Title 3, Chapter 3.23, Section 3.23.010 of the Pasadena Municipal Code is amended to add a new Paragraph X as follows:

**“X. Desiderio Neighborhood Park as depicted on Drawing No. 6181.”**

**SECTION 3.** Title 4, Chapter 4.17, Section 4.17.060 of the Pasadena Municipal Code is amended to add a new Paragraph BB as follows:

“BB. Desiderio Neighborhood Park as depicted on Drawing No. 6181.”

**SECTION 4.** A copy of the Desiderio Neighborhood Park map, Drawing No. 6181 is attached hereto and incorporated herein by reference.

**SECTION 5.** The City Clerk shall certify the adoption of this ordinance and shall cause this ordinance to be published by title and summary.

**SECTION 6.** This ordinance shall take effect upon publication.

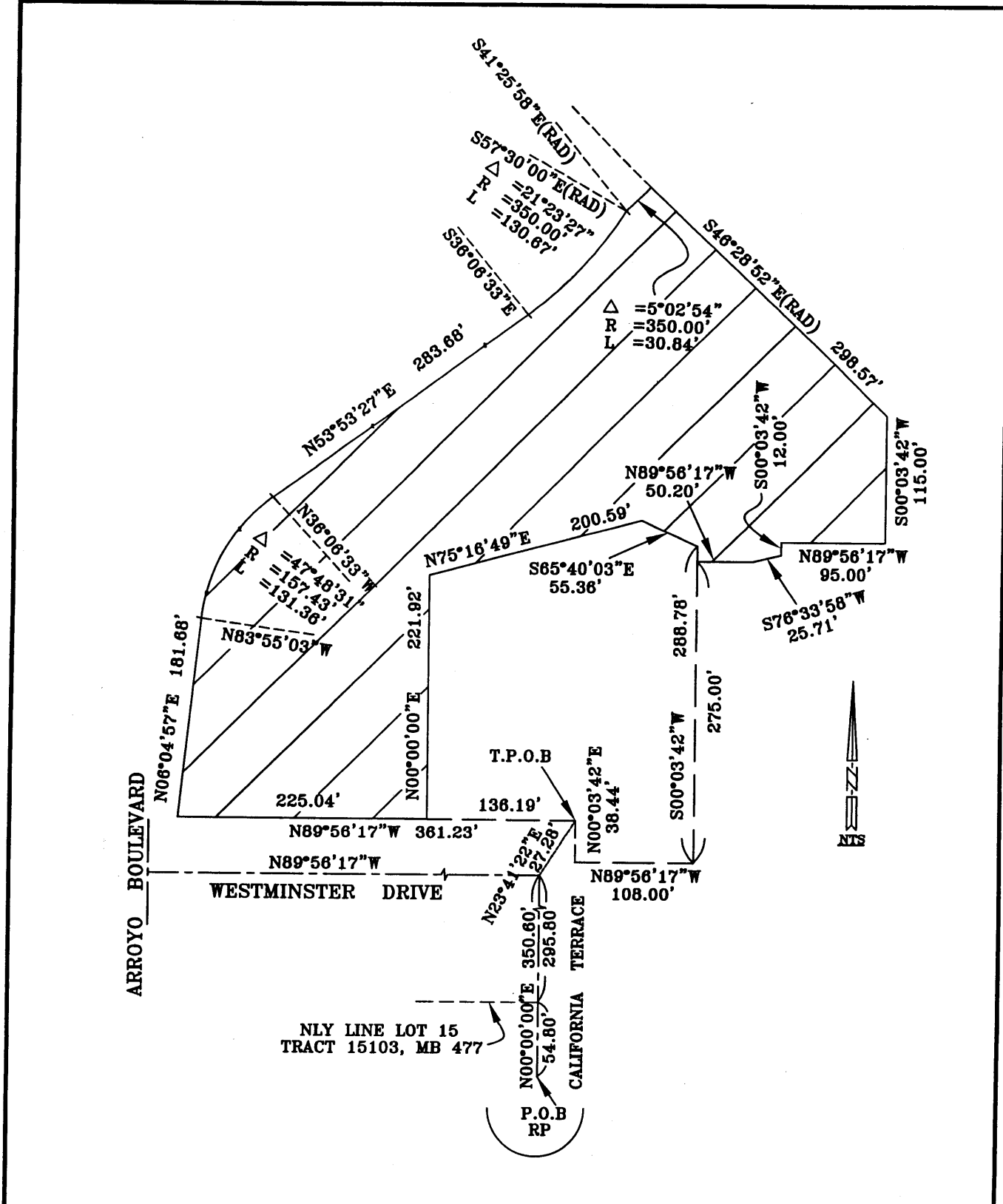
