Dear Mayor Bogaard and Members of the City Council:

Re: Pasadena Roving Archers

It has come to our attention that the Pasadena Roving Archers Archery Range is being considered for elimination. Such a decision would be a terrible mistake and a major blow to the residents of Pasadena. The range has been a great benefit to the community for 80 years and has hosted the likes of Errol Flynn, Ephraim Zimbalist Jr, John Wayne, Howard Hill and many other celebrities in its long history.

A vote to close the range would negatively impact thousands of sports enthusiasts that enjoy the programs offered by the Pasadena Roving Archers Club and disestablish handicapped residents of one sport they can participate in. Additionally, it would destroy children's programs that are continually growing at the archery range such as the Junior Olympic Development Program as other ranges are simply not available without traveling great distances. This past year, hundreds of children were able to receive archery lessons who would otherwise be on the couch playing video games or engaging in less healthy activities. Studies show that kids involved in archery have improved grades, concentration and increased attendance in school. The amazing thing about archery is that virtually anyone can participate in the sport. Young or old, all participants can gain the benefits and improved physical fitness this great sport has to offer.

The fact that the archery range is even being considered for closure is due to a private crusade being driven by one person, who wants the acreage for a private walking path. Her misguided attempt to close down the Pasadena Archery Range is for personal benefit. Below you can see my e-mail from one year ago, so I will not go into much detail.

Once again, I request your support for one of the most lovely and educational sports programs in Pasadena — the Pasadena Roving Archers.

Unfortunately, the "Stewards of Public Land" group has spread so many half-truths and complete fabrications as to be laughable...if not for the influential people who back the group.

- The sport of archery is not dangerous when practiced safely. Safety is one of the top priorities of the instructors that I have met in the Lower Arroyo.
- The archery range is not "devoted to an exclusive private use" as the "Stewards" claim. The archery range is a designated-use area for a specific purpose, just like other City facilities such as Brookside Golf Course, the casting pond, tennis courts, basketball courts, Hahamongna Frisbee golf course, and the lawn bowling field.
- The size of the archery range is not 18 acres as the "Stewards" claim. And the City proposal is not asking for an expansion -- as they claim.

Hello; I have written to you before. My name is Loren Roberts, and I live in the Historic Highlands, and work about a block away from Pasadena City Hall. Previously I wrote to you in support of the Pasadena Roving Archers' continued use of the Lower Arroyo Range (2011-2012), as well as asking for support in All Saint's proposal to modernize their campus (April 2012).

I am asking once again that you support the Pasadena Roving Archers and the full-time use of the Lower Arroyo Archery Range.



Dear Mayor Bogaard and City Councilmembers:

The Board of the San Rafael Neighborhoods Association (SRNA) voted unanimously last evening (September 3, 2014) in support of the city's proposed renegotiated license and operating agreement and updated deal points (February 4, 2014 - Recreation and Parks Commission) allowing for continued presence of the Pasadena Roving Archers (PRA) in the Lower Arroyo.

SRNA has a record of restraint and due diligence in this matter.

SRNA met with the PRA nearly one year ago (September 11, 2013) during a publicly noticed general meeting. We inspected the site on numerous occasions, spoke with neighbors, archers on the range and families pleased to have access to Pasadena's unique environs. We also heard testimony from opponents appearing before council and debated arguments presented on blogs and websites.

Their words show their true intent and, any discussions with them about "sharing" the area are disingenuous at best.


Please consider the following plain simple facts.

Dear City Council members,

As a resident I am strongly in favor of preserving the historic archery range in Pasadena. I feel it is very selfish that a few connected individuals want to close and /or restrict the activities of this wonderful resource we have in Pasadena. Please think before voting about what exactly is it we GAIN by limiting the archery range? Are there not enough dog parks? Are there not enough MILES of walking trails?

Since the late 1970s, the history of archery in the Lower Arroyo has been one of **consolidation**, not expansion. First the PTA range was closed and its memberships were transferred to PRA. Approximately ten years later, the Sagittarius club also folded, and PRA absorbed many of its members and activities. Even though the Sagittarius range (northern range) was not closed at that time, as of the 2003 adoption of the Lower Arroyo Master Plan (LAMP), archery has only been permitted on the Sagittarius range for PRA events on a maximum of 13 Sundays per year. Today, all three archery sports take place regularly within the historic Field Archery Range (southern range). Archery activities that once spread over more than 20 acres on both sides of the channel have now been consolidated into a little less than 10 acres within the confines of the Field Archery Range

Extremely selfish are these people that want to close facilities in the lower arroyo just because they do not participate in the activity!

Preservation of Pasadena Unique Facilities

Hello and thank you for opening my email,

I want to help set the record straight and support the preservation of the historic Lower Arroyo Archery Range.

This open land has been an archery range for almost 80 years now and there has been no reason to change that condition.

The opponents to the range have been decimating FALSE information for along time hoping that you will begin to take it as fact.

Please allow me to show you the truth. Not an opinion but simple fact.

- 1) The Pasadena Roving Archers (PRA) maintain the range and use it for 14 hours per week to provide inexpensive archery instruction to the public and to conduct archery tournaments which are also open to the public. There is no exclusive use of the public land. The PRA has never sought to have this land closed to the public, ever!
- 2) The size of the archery range *is not* 18 acres and there is no plan to increase the current size of the range. According to Pasadena Public Works, the Southern range is approximately 7.5 acres. The northern range is about 4 acres and is only used during official public tournaments. So "sometimes" the range can be up to 11.5 acres but, it is never 18 as the people who are trying to close the range completely are stating on their website.


3) It's important to assess safety based on facts rather than perception. The fact is, there has never been an archery accident at this range in its entire 79-year history.

"archery is one of the safest sports, with an injury rate of less than one incident per 1,000 participants, in 2004 (Table 1). Recreational activities like golf and fishing have an injury rate of up to 1.5 to 2 times the rate for archery (Figure 1). Common sports like soccer, baseball and basketball have injury rates 15 to 25 times that of archery" *

As a member of the public, hese people who want to hoard the land for themselves are welcome to come use the the archery range for archery. They are not prevented from enjoying the land. In fact if they come on Saturday mornings it's free!

Here are some other valid points from the Pasadena Rovers' website that I believe are valid and worth considering:

- 1)The archery range *is not* "devoted to an exclusive private use." It is available for *public* use for archery.
- 2)The size of the archery range *is not* 18 acres and there is no plan to increase the current size of the range. According to Pasadena Public Works, the Southern range is approximately 7.5 acres. This is the only permanent designated-use area for archery in Pasadena. An adjacent Northern range occupying approximately 4 acres is a general-use area currently used for archery less than 8 hours per month with temporary targets; at all other times the Northern range area is available for hiking and other passive recreation uses.
- 3)The agreement under consideration by the Council *does not* "permanently prohibit walking, jogging, dog-walking, birding and other forms of enjoyment of nature on the West side of the Lower Arroyo." All of these activities are currently allowed on the West side of the Lower Arroyo on existing trails that skirt the perimeter of the archery range. The proposed agreement would do nothing to restrict the use of any of these existing trails.
- 4)The "lovely trail" pictured on the Stewards of Public Land web site is actually a target maintenance path that crosses shooting lanes *inside* the boundaries of the archery range. It's already illegal for anyone (archers and non-archers alike) to walk between archers and targets. Currently some pedestrians use this path as a shortcut through the range instead of staying on the City-maintained trail outside the archery range. The proposal before the council aims to delineate the boundaries of the range more clearly in order to prevent inadvertent pedestrian intrusions into the range that compromise safety.

Dear Ms. McAustin,

I am a resident of Pasadena, and a casual archer. I am also an avid hiker and dog owner. I have enjoyed membership with Pasadena Roving Archers when we were living in San Marino, and my boys expressed interest from their Boy Scout experience. I or my family members (wife, 2 boys and a daughter) routinely use this public space at least several times each month. We have sometimes taken friends and relatives down to the range to teach archery basics with beginner Genesis bows, including safety and range etiquette. As a result, one of my boys (Matt, now 20) has become an avid outdoorsman. He often takes his friends (many of whom have not had outdoor experiences) on early morning expeditions into the San Gabriel mountains, teaching them basic wilderness safety skills (both boys are skilled backpackers) as they bow hunt for deer. Regardless of your personal stand on hunting, the fact that Matt is showing other young men safe, mindful, outdoor life that they would never have experienced otherwise, is laudable. I firmly believe that the proximity, easy access and quality of the Arroyo archery range encouraged Matt and his friends to pursue these ventures.

In my opinion, the current use of natural space with trails and archery lanes in the Arroyo is an excellent example of balance for multiple community uses, and preservation of the wilderness area itself. The hiking/jogging trail is well marked, as are signs that mark the range locations, and potential dangers. During my morning visits during the week, the pedestrian traffic is quite low, and some days I can be shooting for several hours without anyone passing by. I will occasionally have a dog walker come by with their dog off-lead. Even though I find this behavior inappropriate in any hiking environment (I never take my dogs off-lead in a public area), I do understand and am watchful for this potential hazard. I occasionally speak to someone who is interested in knowing more about the sport, and are pleased to find out about the introductory class given on Saturday mornings (which is an excellent first date, by the way). I will occasionally run across an archer who is not a member of PRA (usually someone from out of the area or has just moved to Pasadena), and they have been unanimously thankful for the information, and are genuinely interested in joining.

I also believe that use of this area for archery is an excellent conservation measure. Unlike other archery ranges which tend to be large open park areas (El Dorado Park, for example), the wooded areas between and beyond the range are filled with natural habitat. If the ranges were abandoned, and at some future date additional nature pathways were developed, natural habitat would be removed, and in my opinion, the natural ecosystem in the area would suffer. In fact, the archery lanes help support the natural environment by discouraging encroachment. The existing paths are constructed in a way that allow the non-shooting public to enjoy the wilderness without encroaching (and potentially damaging) the native environement. Archers rarely egress beyond the lanes, and responsible archers (e.g. members of Pasadena Roving Archers) do not destroy natural habitat in search of the occasional arrow that misses the mark.

Finally, I would like to express my appreciation for the Pasadena Roving Archers. I am grateful to this public service organization the quality and integrity of their stewardship over the years of this important natural habitat. Their public outreach through Saturday activities, and the safe environment that they have established for both archers and non-archers demonstrate what I consider to be an excellent role model for city/non-profit partnerships.
