- (1) Find the actions proposed in the agenda report are exempt from environmental review pursuant to State California Environmental Quality Act (CEQA) Guidelines Section 15061(b)(3) ("general rule"), Section 15378(b)(4) (definition of project excludes government fiscal activities which do not involve any commitment to any specific project);
- (2) Direct the City Attorney to prepare an ordinance and return within 30 days requiring the payment of a city-wide minimum wage, as follows:
 - a. July 1, 2016 the hourly wage shall be \$10.50
 - b. July 1, 2017 the hourly wage shall be \$12.00
 - c. July 1, 2018 the hourly wage shall be \$13.25
- (3) Direct staff: a) to return to the City Council no later than February 18, 2019 with a report assessing the impact of the local minimum wage on reducing poverty, unemployment, job creation, and the overall local business climate as further described in the background section of the agenda report; and,
 - b) request direction from the City Council regarding an amendment to the Pasadena Minimum Wage ordinance to increase the wage, as follows:
 - a. July 1, 2019 the hourly wage shall be \$14.25
 - b. July 1, 2020 the hourly wage shall be \$15.00
 - c. Beginning July 1, 2022 and each July 1 thereafter, the hourly wage shall adjust by an amount equal to the change in the Los Angeles-Riverside-Orange County consumer price index for Urban Wage Earners and Clerical Workers:

- (4) Provide policy direction on elements of the proposed ordinance as outlined in the background section of the agenda report; and
- (5) Direct staff to take appropriate actions and return as necessary to the City Council to increase compensation rates for City employees earning less than the City-wide minimum wage except those employed in job-training and youth employment programs as discussed in the body of the agenda report.

Councilmember Kennedy stated his support for the staff recommendation, which is a measured approach to the proposed city-wide minimum wage increase. In addition, he expressed concerns with the "Learners" exemption and asked staff to analyze unintended negative impacts on small businesses.

Councilmember Hampton requested that staff determine if incentives can be provided to small businesses to offset some of the fiscal impacts associated with the proposed action. He also advocated for the City to dedicate a staff person to wage enforcement, and spoke in support of the "Learners" exemption.

Councilmember Wilson stated for the record that he supports regional consistency in establishing a minimum wage, and voiced his support for staff's recommendation to return to the City Council no later than February 18, 2019 with an update prior to proceeding with the proposed increase to \$15.00 per hour. In addition, he requested that staff establish measures and reportable metrics for the City to understand the impacts of the proposed increase. Councilmember Wilson stated that he does not support an exemption for the City's youth employment programs, and expressed his disappointment that the staff did not include a "total income approach" as part of the recommendations.

Vice Mayor Masuda voiced his support for wage enforcement and expressed concerns regarding the possible negative impacts to Pasadena's businesses.

Councilmember Madison expressed his concerns regarding staff's recommendation that would require the City Council to take a second action in order to proceed to \$15.00 on July 1, 2020, and the lack of age requirements and hours with the "Learners" exemption. In addition, Councilmember Madison asked staff to return to the City Council with a robust public and private wage enforcement program.

Councilmember Gordo stated his support for a comprehensive wage/theft enforcement program that includes private action, treble damages, and attorney fees. He suggested a model for public enforcement that would include partnering with local non-profits organizations, employer/employee education, a posting

program, consumer action representation, and utilization of the City Prosecutor's Office, as well as Los Angeles County and State Labor Commissioner enforcement, to assist with wage enforcement. In addition, he expressed concerns with the "Learners" exemption and suggested utilizing the City of Los Angeles' model, with the age limit parameters of 14 to 17 years of age, and reducing the hours to 160 hours. Councilmember Gordo asked staff to establish and monitor economic metrics, including reported tax sales and statistics related to break-out businesses/industry, and return to the City Council with a report.

Discussion ensued on the seven discussion points articulated in staff's agenda report regarding the provisions to be included in the proposed ordinance, with the City Council providing the following direction on each point:

The City Council agreed by consensus to approve a "Small Business Deferral" providing a one-year delay in implementation of wage increases for employers with twenty-five or fewer employees.

The City Council agreed by consensus to approve the "Certain Non-Profits Deferral" (providing a one-year delay in implementation of wage increases) for those non-profits with 26 or more employees, that meet the following criteria:

- (a) The chief executive officer earns a salary which, when calculated on an hourly basis, is less than five times the lowest wage paid by the corporation; or
- (b) It is a Transitional Employer (i.e., an organization that provides transitional jobs for the long-term unemployed); or
- (c) It serves as a child care provider; or
- (d) It is funded primarily by City, County, State or Federal grants or reimbursements.

The City Council did not agree to Total Earnings exemption.

Following discussion it was moved by Councilmember Gordo, seconded by Councilmember Kennedy, to incorporate in the drafted ordinance a "Learners" Exemption; defining "Learners" as employees who are 14-17 years of age, and shall be paid no less than 85% of the applicable minimum wage for the first 160 hours of employment. (Motion carried with Councilmembers Hampton, Wilson objecting) (Absent: Councilmember McAustin)

Following discussion, it was moved by Councilmember Wilson, seconded by Councilmember Kennedy, to allow for the phased approach with regard to implementation of the minimum wage ordinance in order to achieve the \$15.00/hour minimum wage,

amended to require an affirmative vote (following staff's report back to City Council by February 18, 2019 on the impacts) as confirmation of the ordinance prior to proceeding with increases on July 1, 2019 (\$14.25) and July 1, 2020 (\$15.00), with CPI increases to occur annually after that.

Following further discussion, it was moved by Councilmember Kennedy, seconded by Councilmember Wilson, to direct staff to develop an enforcement plan, with EDTech Committee to review the plan prior to full City Council consideration, with the following issues to be addressed in the proposed ordinance:

(1) Private enforcement (allowing for the collection of attorney's

fees, treble fines, etc.);

(2) Strong commitment to a focused local enforcement piece (City staff), utilizing existing positions to assist in enforcement management;

(3) Collaboration with other partner agencies (State and County) that are responsible for wage and theft enforcement; and

(4) Utilization of non-profit and community organizations to assist with outreach and education. (Motion unanimously carried) (Absent: Councilmember McAustin)

Following discussion, it was moved by Councilmember Madison, seconded by Councilmember Gordo, to direct staff to apply increases, consistent with the proposed minimum wage increases and timeframes, to the City's workforce, through amendments of salary resolutions and Memorandum of Understandings (MOU's), including the "Learners" exemption.
