Recommendation:

(1) Find that the action proposed in the agenda report is not a "project" as defined in the California Environmental Quality Act (CEQA), Public Resources Code Section 21065 and Section 15378(b)(2) of the State CEQA Guidelines and, as such, is not subject to environmental review; and

(2) Authorize the Interim City Manager to enter into a contract, without competitive bidding pursuant to City Charter Section 1002(F), contracts for professional or unique services, with AdminSure for workers' compensation administration of claims in an amount not-to-exceed \$613,110, with four (4) optional, one-year periods in an amount not-to-exceed \$646,475 per year without further City Council authorization. Jennifer Curtis, Director of Human Resources, and Antoinette Joseph, Workers Compensation Supervisor, responded to questions regarding the current workers' compensation claim administration and fiscal components of the proposed contract.

Councilmember Wilson requested information on the bid amounts submitted by all vendors bidding on the contract and suggested that future criteria used by staff include ability to perform when awarding contracts.


Councilmember Gordo requested that staff prepare performance metrics to track and better understand Adminsure's performance in administering the City's Workers Compensation program. In addition, Mr. Gordo requested information on the current number of active workers' compensation claims, the timeliness of a claim's progress through the process, and data related to employees' ability to return to work in a timely manner.

Councilmember Hampton requested information on the yearly number of workers compensation claims filed, with multiple claims by the same employee noted, and the City's actions to address complaints.

Steve Mermell, Interim City Manager, responded that the information requested above will be provided in the City Manager's weekly newsletter.

Following discussion, it was moved by Councilmember Wilson, seconded by Councilmember Hampton, to approve the staff recommendation. (Motion unanimously carried) (Absent: None)

Mayor Tornek, Chair of the Finance Committee, provided a brief summary of the presentations and proposed CIP projects discussed at the special Joint Finance Committee and City Council meeting held at 2:30 p.m., and stated that the CIP budget review will continue on May 16, 2016 at 3:00 p.m.

Following a brief discussion, it was moved by Councilmember Gordo, seconded by Vice Mayor Masuda, to continue the public hearing listed above to May 16, 2016 at 7:00 p.m., noting a special Joint Finance Committee and City Council meeting will occur at 3:00 p.m. to continue the CIP Budget review. (Motion unanimously carried) (Absent: None)

PUBLIC HEARING: FISCAL YEAR 2017 RECOMMENDED OPERATING BUDGET

Recommendation:

(1) Open the public hearing for the Fiscal Year 2017 Recommended Operating Budget; and

(2) Continue the public hearing to each subsequent regular meeting of the City Council at 7:00 p.m., until June 20, 2016 or such other date as the City Council may determine, and at which time the City Council will be asked to close the public hearing and formally adopt the Fiscal Year 2017 Recommended Operating Budget.

The City Clerk opened the public hearing; reported that the notice of public hearing was published in the <u>Pasadena Journal</u> on April 21, 2016; and no correspondence was received by the City Clerk's office regarding this item.

Steve Mermell, Interim City Manager, provided a PowerPoint presentation on the Fiscal Year 2017 Recommended Operating Budget, and responded to questions. Matthew Hawkesworth, Finance Director, respond to questions regarding full time employees supported by General Fund monies, budget appropriations, and general revenue taxes.

Councilmember Hampton suggested that staff evaluate the City's services provided across City departments, to identify overlapping or obsolete services that may exist and potential efficiencies that can be gained.

Councilmembers Wilson, Hampton, and Gordo stated their support for staff to review the Transient Occupancy Tax (TOT) agreement with Pasadena Center Operating Company (PCOC) in order to identify the appropriate percentage of tax revenue needed to fund PCOC operations, with the remaining amount to be directed to the City's General Fund to fund City services.

Councilmember Madison expressed concerns with using TOT funds without an established policy, and that the PCOC Board be consulted prior to any action taken by the City In addition, Mr. Madison requested information on the percentage of the City's general fund spent on public safety in comparison to the cities of Burbank and Glendale, and an implementation status update on the recommendations directed by the Task Force on Financial Administration and Internal Controls.

Councilmember Gordo requested that the Interim City Manager provide a report with recommendations on a cost recovery analysis for City services, review of legacy services that may no longer be needed, and review of potential revenue opportunities in the City, with consideration given to convening a revenue generation task force or contracting a consultant. Mr. Gordo also suggested the City explore a parcel tax to fund public safety and the Pasadena Police Department.

Following discussion, it was moved by Councilmember Kennedy, seconded by Councilmember Hampton, to continue the public hearing listed above to May 16, 2016 at 7:00 p.m., noting the continued Joint Finance Committee and City Council meeting will occur at 3:00 p.m. (Motion unanimously carried) (Absent: None)

REPORTS AND COMMENTS FROM COUNCIL COMMITTEES

POLYSTYRENE FOOD PACKAGING ORDINANCE Recommendation:

(1) Find that the Polystyrene Food Packaging Ordinance is exempt from the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines Section 15061(b)(3) (General Rule) and also under Section 15308 as an action by a regulatory agency (the City of Pasadena) for the protection of the environment; and

(2) Direct the City Attorney to draft the Polystyrene Food Packaging Ordinance, to reduce and prevent polystyrene food packaging in the environment and promote environmentally sustainable practices in the City, within 60 days consistent with the provisions set forth in the agenda report.

Recommendation of the Municipal Services Committee: On December 8, 2015, staff presented the draft Polystyrene Ordinance to the Municipal Services Committee (MSC) and was directed to further explore the potential economic impacts on restaurants, especially small businesses that may be using polystyrene packaging, and the cumulative impacts of the pending minimum wage increase and the Affordable Care Act.

On April 26, 2016, staff returned to MSC with the requested additional information. MSC acknowledged the importance of an education and outreach campaign to the success of the ordinance and recommended that it be comprehensive in including residents as well as business owners. MSC voted to approve the Polystyrene Food Packaging Ordinance.

Recommendation of the Environmental Advisory <u>**Commission:**</u> On October 20, 2015, Department of Public Works staff presented the draft Polystyrene Food Packaging Ordinance to the Environmental Advisory Commission (EAC). The EAC recommended some minor language edits (that were incorporated by staff) and voted unanimously to recommend that City Council approve the draft Polystyrene Food Packaging Ordinance.

Ara Maloyan, Director of Public Works introduced the agenda item, Gabriel Silva, Environmental Programs Manager, presented a PowerPoint presentation on the item, and responded to questions.

Councilmember McAustin, Chair of the Municipal Services Committee, summarized the Municipal Services Committee's discussion regarding the proposed action.

Councilmember Hampton stated his support for the staff's recommendation and asked staff to explore the possibility of a second Materials Reclamation Facility (MRF) where the current recycle facility is located, and asked staff to provide information on other cities that have banned Styrofoam in grocery markets, including meat departments.

Councilmember Kennedy stated for the record that he will be investing in a company that repurposes polystyrene. Mr. Kennedy suggested a more restrictive recommendation that includes banning polystyrene completely within the City.
