I am puzzled and confused by this proposal as I attended the April, 2013 Council meeting at the convention center and have been involved in the NO710 Coalition for several years. I do not understand why Mayor Tornek is trying to push this through now since a deciding vote was already made before his mayoral election.

At that council meeting members discussed Measure A. A council majority agreed that because the current proposal for a 710 toll tunnel did not coincide with the planned 2001 freeway in Measure A, among other differences, such as adding 10,000 trucks each day. The majority of the council voted against the 710 Extension.

Mayor Tornek voted For the 710 Tunnel as I recall.

Did the Majority Vote have no purpose?

Does the Majority Vote not count when someone else becomes mayor?

Mayor, how do you know we will be "ambushed"? What do you know and from whom?

Can we have that information too please? At the aforementioned meeting, the majority of the City Council members did not agree with you that Measure A "restricts" our ability to oppose the 710 Extension.

City Attorney Baggers states that no monies may be raised or spent by our city unless Measure A is repealed. Do I remember correctly that other attorneys disagreed with her conclusion?

If Mayor Tornek has not polled the Council Members, how does he know that "The Council is unanimous in it's opposition to the 710 Tunnel"?

The meeting at the convention center did NOT have unanimous opposition to the Tunnel. What changed?

In facet, some of our current City Council Members were not on our Council and did not vote at all. So in fact, unless they have been "polled", we do Not know their position nor vote on this matter.

Pasadena is NOT, I repeat, is NOT "sort of participating" in the process to stop the 710.

There are numerous meetings, working sessions, and coalitions with many, many other cities and groups, also attendance at Metro Board meetings, and countless other activities and events over these many years.
