AN ORDINANCE OF THE CITY OF PASADENA AMENDING TITLE 2, CHAPTER 2.05, SECTIONS 2.05.160 THROUGH 2.05.200 OF THE PASADENA MUNICIPAL CODE TO ESTABLISH THE QUORUM OF CITY COUNCIL COMMITTEES AS TWO MEMBERS

The People of the City of Pasadena ordain as follows:

- **SECTION 1.** Pasadena Municipal Code, Title 2, Chapter 2.05, Section 2.05.160, subdivision (B), is amended to read as follows:
- B. The finance committee shall be composed of up to 4 members of the city council appointed by the mayor. If 4 members are appointed, 3 **2** members shall constitute a quorum. No action of the committee shall be valid without the affirmative vote of at least 2 members.
- **SECTION 2.** Pasadena Municipal Code, Title 2, Chapter 2.05, Section 2.05.170, subdivision (B) is amended to read as follows:
- B. The economic development and technology committee shall be composed of up to four (4) <u>4</u> members of the city council appointed by the mayor. If four (4) <u>4</u> members are appointed, three <u>3</u> <u>2</u> members shall constitute a quorum. No action of the committee shall be valid without the affirmative vote of at least two (2) <u>2</u> members.
- **SECTION 3.** Pasadena Municipal Code, Title 2, Chapter 2.05, Section 2.05.180, subdivision (B) is amended to read as follows:
- B. The legislative policy committee shall be composed of up to 4 members of the city council appointed by the mayor. If 4 members are appointed, 3 **2** members shall constitute a quorum. No action of the committee shall be valid without the affirmative vote of at least 2 members.
- **SECTION 4.** Pasadena Municipal Code, Title 2, Chapter 2.05, Section 2.05.190, subdivision (B) is amended to read as follows:

- B. The public safety committee shall be composed of up to 4 members of the city council appointed by the mayor. If 4 members are appointed, **2** 3 members shall constitute a quorum. No action of the committee shall be valid without the affirmative vote of at least 2 members.
- **SECTION 5.** Pasadena Municipal Code, Title 2, Chapter 2.05, Section 2.05.200, subdivision (B) is amended to read as follows:
- B. The municipal services committee shall be composed of up to 4 members of the city council appointed by the mayor. If 4 members are appointed, 3 <u>2</u> members shall constitute a quorum. No action of the committee shall be valid without the affirmative vote of at least 2 members.
- **SECTION 6.** The City Clerk shall certify the adoption of this ordinance and shall cause this ordinance to be published in full text.
