A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASADENA TO ESTABLISH A PREFERENTIAL PERMIT PARKING DISTRICT (DISTRICT "LC") WITHIN WHICH PREFERENTIAL PARKING PRIVILEGES WOULD BE GRANTED TO RESIDENTS.

WHEREAS, California Vehicle Code Section 22507 authorizes the local authority to install signs giving notice that no person shall stand, stop or park a vehicle, except as provided on such signs; and

WHEREAS, Pasadena Municipal Code Section 10.40.170 authorizes the Director of Transportation ("the Director") to install signs giving notice that no person shall stand, stop or park a vehicle, except as provided on such signs; and

WHEREAS, Pasadena Municipal Code Chapter 10.41, "Preferential Parking Ordinance", establishes a preferential parking program for residential neighborhoods whereby permit parking only districts can be established according to certain criteria in order to relieve congestion in those districts;

WHEREAS, the City Council has adopted rules and procedures for the designation of preferential parking districts setting forth the criteria for designation of a preferential parking district and for the implementation and administration of the program.

WHEREAS, on January 30, 2017 the City Council approved a resolution (No. XXXX) for establishing a preferential parking program to include La Canada Verdugo Road; Vista Laguna Terrance between La Canada Verdugo Road and 2445 Vista Laguna Terrace; and Arroyo Boulevard between La Canada Verdugo Road and Woodbury;

WHEREAS, the Department of Transportation has designated the affected area as Preferential Parking Program (PPP) District "LC" for administrative purpose;

WHEREAS, the unrestricted on-street parking immediately adjacent to the PPP District “LC”, adjacent to the entrance of Hahamongna Watershed Park occupied by non-local vehicles in which the streets cannot be used for parking by the residents or their guests and that such unrestricted parking substantially and unreasonably, regularly interferes with the use of a majority of the available public street parking; is a source of interference with the residential environment and detrimentally affects the public welfare;

WHEREAS, the City Council has found that the establishment of PPP District “LC” is necessary and prudent to mitigate the direct impact of non-local parking destined for Hahamongna Watershed Park; and that establishment of the preferential parking district is consistent with procedures and the ordinance;

WHEREAS, the Director of Transportation is empowered to implement a preferential parking program in a preferential parking district created by City Council resolution;

THEREFORE, the City Council of the City of Pasadena hereby establishes District “LC” to include the following streets pursuant to Chapter 10.41 of the Pasadena Municipal Code:

1. Both sides of La Canada Verdugo Road
2. Both sides of Vista Laguna Terrance between La Canada Verdugo Road and 2445 Vista Laguna Terrace
3. Both sides of Arroyo Boulevard between La Canada Verdugo Road and Woodbury Road


