**A RESOLUTION OF THE CITY OF PASADENA DECLARING THE RESULTS
OF THE CITY'S CONSOLIDATED PRIMARY NOMINATING ELECTION
HELD ON TUESDAY, MARCH 7, 2017**

WHEREAS, a Primary Nominating Election for members of the City Council in Districts 3, 5, and 7 of the City of Pasadena was called by the City Council to be held on March 7, 2017, to be consolidated with the Pasadena Unified School District Primary Nominating Election for Board of Education, Districts 1, 3, 5, and 7, to be held on said date; and

WHEREAS, the Los Angeles Registrar Recorder/County Clerk canvassed the returns of the election and certified the results to the City Council, and those results are attached as "Exhibit A" and incorporated herein by reference; and

WHEREAS, said City Clerk has certified the results of said canvass to the City Council of the City of Pasadena.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pasadena that:

1. The following be declared to be the results of the Primary Nominating Election for members of the City Council, Districts 3, 5, and 7:

DISTRICT 3 (Full, four-year term)

2. That John J. Kennedy, having received a majority of the total votes cast for candidate for the office of Member of the City Council from District 3, from which the candidate sought nomination, hereby is declared to be re-elected as Member of the City Council from District 3 for a full term of four years.

3. That Victor M. Gordo, having received a majority of the total votes cast for candidate for the office of Member of the City Council from District 5, from which the candidate sought nomination, hereby is declared to be re-elected as Member of the City Council from District 5 for a full term of four years.

4. That Phil Hosp and Andy Wilson, being the two persons receiving the highest number of votes for the office of Member of the City Council from District 7, shall be the two candidates for election by Council District 7 at the City of Pasadena General Municipal Election to be held on April 18, 2017.
