I am expecting to attend the meeting tonight but wanted to register my support in advance and do not expect to need to make a further statement.

When the City Council previously discussed the subject of a potential park in The Playhouse District, the conversation seemed to get sidetracked by a very few vocal local business people who expressed the need for more parking and the conversation got derailed. I was there to show my support for continuing the park discussion, and I am now pleased to support the idea of including the Banner Bank property in the discussion. I do not believe parking to be an issue. None of my guests has ever had a problem finding parking, and we moved in in 2007. I always tell them to contact me if they cannot find parking and I will escort them into the underground parking in our building. It never happens. In addition, we practically live in the Vroman's parking lot. We walk it practically every day. We know it could be better managed; many local workers, movie goers, etc., use the Vroman's lot.
