

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASADENA DECLARING THE RESULTS OF THE CITY'S CONSOLIDATED SPECIAL MUNICIPAL ELECTION HELD ON TUESDAY, JUNE 5, 2018

WHEREAS, a Special Municipal Election was held in the City of Pasadena (City) for ballot measures AA, BB, CC, and DD, and in the territory annexed thereto for Pasadena Unified School District (PUSD) purposes for ballot measure BB, consolidated with the June 5, 2018 Statewide Primary Gubernatorial Election; and

WHEREAS, the Los Angeles County Registrar-Recorder/County Clerk conducted the election on behalf of the City and PUSD, canvassed the returns of said election, and certified the results to the City Council, with said results attached as "Exhibit A" and incorporated herein by reference; and

WHEREAS, said City Clerk has submitted the certified results of said canvass to the City Council of the City of Pasadena.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pasadena that:

1. The following be declared to be the results of the Special Municipal Election for ballot measures AA, BB, CC, and DD:

MEASURE AA

Yes	21,470 votes	(83.01 %)
No	4,394 votes	(16.99 %)

MEASURE BB

Yes	34,549 votes	(85.07 %)
No	6,064 votes	(14.93 %)

MEASURE CC

Yes	16,099 votes	(60.82 %)
No	10,370 votes	(39.18 %)

MEASURE DD

Yes	19,699 votes	(75.95 %)
No	6,237 votes	(24.05 %)

2. That as a result of the election, a majority of the voters voting on Measure AA did vote in favor, that the Measure was approved, and shall be deemed adopted and ratified.

3. That as a result of the election, a majority of the voters voting on Measure BB did vote in favor, that the Measure was approved, and shall be deemed adopted and ratified.

4. That as a result of the election, a majority of the voters voting on Measure CC did vote in favor, that the Measure was approved, and shall be deemed adopted and ratified.

5. That as a result of the election, a majority of the voters voting on Measure DD did vote in favor, that the Measure was approved, and shall be deemed adopted and ratified.
