(2) Accept the bid dated December 28, 2018, submitted by Mariposa Landscapes, Inc., in response to Notice Inviting Bids for Tree Trimming and Tree Maintenance, reject all other bids received, authorize the City Manager to enter into such contract for palm tree pruning for an amount not-to-exceed \$999,600 (which includes a contingency of \$33,000) over a three-year period, authorize the City Manager to extend the contract for up to two additional one-year terms in the annual amount of \$333,200

HERITAGE SQUARE SOUTH DEVELOPMENT PROCESS AND AUTHORIZATION TO NEGOTIATE A DEVELOPMENT AGREEMENT WITH BRIDGE HOUSING

Recommendation: It is recommended that the City Council take the following actions:

- (1) Find that the proposed action is exempt from the California Environmental Quality Act ("CEQA") in accordance with State CEQA Guidelines Section 15061(b)(3), the "general rule" that CEQA only applies to projects that may have an effect on the environment; and
- (2) Authorize the City Manager to enter into negotiations with Bridge Housing to become the developer for a mixed-use project on the City-owned property known as Heritage Square South without competitive selection based upon the best interests of the City, as set forth in the agenda report, and to return to City Council with a proposed Development Agreement after completion of a community outreach process. Competitive bidding is not required pursuant to City Charter Section 1002(F) (Professional or Unique Services). (Contract No. 23,101)

William Huang, Director of Housing and Career Services, presented a PowerPoint presentation on the agenda item, and responded to questions. Jim Wong, Senior Project Manager, responded to questions regarding the sources of funding related to the project. Kimberly McKay, Executive Vice President, and Anna Slaby, Senior Project Manager, representing BRIDGE

Housing, and Donna Hess, Heritage Property Manager, responded to question regarding local hiring, local sourcing of materials related to the proposed project, and residents of the Heritage Square North facility.

Vice Mayor Kennedy praised BRIDGE Housing representatives for the service and leadership provided to the residents of Heritage Housing North; but stated his preference that the project developer be chosen through a Request for Proposal (RFP) process.

Councilmember Hampton encouraged BRIDGE Housing and City staff to continue efforts in engaging the local community for the proposed project; and asked staff to consider any action that can be taken to expedite the approval process to complete the project.

Councilmember Gordo suggested that the proposed project be distinct in its architectural design when compared with the Heritage Square North building; and stated the need for staff to assess the operator's ability to identify and leverage funding to complete the project. He requested that staff meet with Los Angeles County and Housing and Urban Development (HUD) staff to secure a specific number of dedicated project-based vouchers for the proposed project, avoid any negative impacts to the City's affordable housing inventory; and requested periodic reports on milestones achieved for the project. Councilmember Gordo stated his preference that the City retain control of the property, and asked staff to investigate options in entering into a long-term lease agreement.

Councilmember Madison disconnected telephonically and was excused at 7:18 p.m.

Councilmember McAustin spoke in favor of the staff recommendation; and asked staff to consider expediting affordable housing projects through the City's approval process.

Councilmember Wilson echoed Councilmember Gordo's comments related to the architectural design of the proposed project, stating his preference that the two developments maintain separate distinctive design features, and expressed concerns with the projects' budget and parking ratio requirements for the project.

The Mayor spoke on the "Every Person Has A Name" event, a 25-hour community-wide Holocaust remembrance ceremony held at City Hall, which began on January 26, 2019 at 7:00 p.m., and concluded on January 27, 2019 at 8:00 p.m. He also spoke on a Buddhist Temple luncheon birthday celebration that was held on Sunday, January 27, 2019; and remarked on the many diverse and unique community events and activities held in Pasadena.
