PRESENTATION BY COUNCILMEMBER MCAUSTIN ON THE CITY'S CELEBRATION OF THE 100TH ANNIVERSARY OF WOMEN'S SUFFRAGE

Councilmember McAustin spoke on the collaborative efforts among City staff and the Commission on the Status of Women to celebrate and recognize the 100th Year Anniversary of Women's Right to Vote, and unveiled a commemorative logo celebrating the anniversary:

DISCUSSION REGARDING THE IMPLEMENTATION OF MEASURE J

Recommendation: The oral report is for information only; no City Council action is required.

City Manager Mermell, provided introductory comments, and Leslie Barnes, Ed.D., Chief Business Officer, provided a PowerPoint presentation on Pasadena Unified School District's funding priorities, fiscal stabilization strategies, reporting and fiscal oversight features, prioritized funding categories, and the impacts of declining enrollment; and responded to questions.

Councilmember Gordo requested detailed information on grant funding opportunities that might be utilized to restore PUSD programs, including the amount of each grant, the effected program and students, and the amount of funding, if any, provided by the state.

Dr. Brian McDonald, Superintendent of Schools, responded to questions related to PUSD's plan to mitigate impacts created by declining enrollment of PUSD students.

Councilmember Madison requested an update on when the PUSD's Facilities Master Plan will be completed; and reiterated his concerns regarding the City Council's need for accountability to City constituents on how PUSD will utilize Measure J funds, the benefits this will provide to Pasadena students, and key performance indicators needed to measure success/impacts.

In response to Councilmember Madison's concerns, President Torres stated that the Board of Education will consider what measures to take and information to provide with regard to performance and accountability.

Following discussion, Councilmember McAustin recommended that staff budget as set amount of approximately \$5 or \$6 million in funding to the PUSD due to the uncertainty in the amount of taxes to be collected.

Councilmember Hampton requested information on why PUSD students are leaving the district and enrolling in other schools; and spoke in favor of providing funding opportunities to Charter

Schools in the City. He also spoke on the need to improve PUSD's aesthetics around schools to increase curb appeal and asked PUSD board members to budget for school façade maintenance.

The Mayor stated that he would support PUSD actions if the School Board decides, after their budgetary process, that students would benefit from allocating funds to Charter Schools.

POSSIBLE FORMATION OF A STANDING JOINT SUBCOMMITTEE OF THE CITY AND PUSD

Recommendation: The oral report is for information only; no City Council action is required.

The Mayor summarized the City Council's discussion on the item and stated that there is a consensus of the City Council and the Board of Education to form a standing joint subcommittee of the City and PUSD.

President Torres spoke in favor of the opportunity to work with the City to create a unique partnership.

Member Kenne stated her preference that the proposed standing committee's purpose, role, and charge be clarified in writing, as well as detail regarding members and frequency of the meetings.

Councilmember Wilson spoke in favor of the formation of a standing joint subcommittee of the City and PUSD.

UPDATE ON COLLABORATE PASADENA

Recommendation: The oral report is for information only; no City Council action is required.

The Mayor made introductory comments on the evolution of the Collaborate PASadena program; and Dr. Donald Grant and Geoff Albert representing Collaborate PASadena through Pacific Oaks College, provided a PowerPoint presentation on transitioning Collaborate PASadena to Pacific Oaks Center for Community and Social Impact, shared missions, primary and supporting goals, and responded to questions.

Christine Lenches-Hinkel, 301 Organics, acknowledged the work of Collaborate PASadena, and spoke on possible future collaborative opportunities.

Following discussion, on order of the Mayor and President, the information was received and filed.

OFFICE OF THE YOUNG CHILD

Recommendation: The oral report is for information only; no City Council action is required.

Crystal O'Grady, Early Childhood Coordinator, Office of the Young Child, and Dr. Ying Ying Goh, Medical Director for Programs and Research, jointly presented a PowerPoint presentation on the Office of the Young Child Health Officer's various programs, including 2018 achievements, recommendations, and goals of the program; and responded to questions.

Councilmember Kenne asked staff to encourage Early Development Instrument (EDI) research to gain information on the incoming kindergarten students in relation to completing pre-school. She spoke on the Community Health and Improvement Plan format and encouraged Collaborate Pasadena to view the format of the outlined goals and indicators.

Vice Mayor Kennedy spoke on the importance of instructors teaching in an unbiased manner, and encouraged the Office of the Young Child to work with PUSD, and utilize tools such as EDI research and other predicting measurements to ensure all children have high success rates irrespective of race.

Bill Gould, First 5 LA, suggested that the City could emulate the City of Los Angeles who proposed considering locating childcare centers at public parks and other suggestions.

Councilmember Gordo suggested that the City Council and Board of Education focus on restoring some programs and services that were eliminated during recession years.

Following discussion, on order of the President and Mayor, and by consensus, the information was received and filed.

UPDATE ON YOUTH MASTER PLAN

Due to time constraints, the City Council and PUSD agreed to delay the discussion on the above item at a future meeting.

ADJOURNMENT

On the order of the President and Mayor, the special joint meeting of the City Council and Pasadena Board of Education adjourned at 10:23 p.m.
