CEREMONIAL MATTERS

Fred Alcantar, President of Pasadena Sister Cities Committee, introduced Student Exchange Program participants, Titta Maria Hurme, Juha Petteri Haapola, Oona Ilona Kuoppa, Santeri Iisakki Ropponen, Siiri Anni Inkeri Sihvonen, Erika Sofia Ktilainen, and

Juho Akseli Kangas from Sister-City Järvenpää, Finland, who thanked the City Council and staff for the opportunity to participate in the program.

They Mayor presented Keith Jones, Chair of the Fire and Police Retirement System Board (FPRS), with a commendation on their 100th Anniversary. Mr. Jones expressed gratitude to the Mayor and City Council for their recognition of FPRS's centennial celebration.

Vice Mayor Kennedy, Councilmembers Hampton and Gordo spoke on the passing of John Singleton, film director, screenwriter, producer and Blair High School Alum, expressed sympathies on his passing, and asked that the meeting be adjourned in his memory.

Jose Ruelasortiz, Rodi Andreescu, Dr. Amed Lopez, and Kristine Stanley, all representing Rojo's Better Life Center, provided information on veteran services and requested City funding to support the organizations efforts in this area of need for veterans in the Community.

Councilmember Hampton and Vice Mayor Kennedy suggested that representatives from Rojo's Better Life Center contact the City's Housing and Health Departments to determine if any grant funds are available for their services.

City Manager Mermell noted that William Huang, Housing Director, has met with Mr. Rogelio Ramirez on numerous occasions to explain the Community Development Block Grant application process.

Councilmember Gordo requested that staff provide information on the services provided by the Los Angeles County Department of Mental Health in the City, and if those services may be provided through Rojo's Better Life Center agency; and determine if the City's Housing Department provides U.S. Department of Housing and Urban Development-VA Supportive Housing (HUD-VASH) program certificates. He also stated his desire for City staff, representatives from the Los Angeles County Housing and Mental Health Departments, and the U.S. Department of Veterans Affairs to meet with Rojo's Better Life Center representatives to determine what programs and services may be available to better serve veterans in the community.

Pablo Alvarado, Pasadena Job Center, requested that the Mayor provide a proclamation to honor the contributions of immigrants and day labors to the community.

PLANNED DEVELOPMENT 36 – PASADENA GATEWAY 3200 E. FOOTHILL MIXED-USE PROJECT ("SPACE BANK") Recommendation: The following report is for information only, no City Council action is required. The purpose of this report is to provide information regarding the status of the subject project and advise the Council and community as to steps staff have initiated in regard to concerns raised regarding remediation of toxic substances located at the project site.

City Manager Mermell provided introductory comments, and David Reyes, Director of Planning and Community Development, presented a PowerPoint presentation on the item; and responded to questions.

Councilmember Masuda and Gordo expressed concerns with the item agendized as in "Information Item"; procedural and credibility concerns with the State of California Department of Toxic Substances (DTSC) (as noted in their e-mail to the Mayor, dated April 22, 2019); and requested that the item be agendize for a full discussion at a future City Council meeting.

In response, the Mayor stated that he believes the process the City has embarked on will respond to all of the stated concerns noted in the email, however after discussion on the item, the matter may be re-agendized by the City Council with a specific action.

Councilmember Gordo expressed concerns with the developers remarks related to the DTSC's Draft of the Removal Action Workplan (DRAW) and the proposed standard levels of cleanup on the site, and requested that the City's environmental consultant (Alta Environmental) provide information on the following:

- Documentation regarding the land control agreement between DTSC and the project developers;
- The various standard levels that may be required by DTSC for an environmental site cleanup;
- Review of the project developers comments to determine if a Remedial Action Plan (RAP) is appropriate instead of a Removal Action Workplan (RAW);
- An analysis on the Transportation Priority Project (TPP) qualifications, including the requirement that all potential and significant impacts are identified, and mitigation by the developer is required for those impacts;
- An analysis on the closed water wells in close proximity to the site, including feedback from the water master; and
- An explanation of the Settlement Agreement distributed by Mr. Gordo related to the item, including a response from the City Attorney on how the scope of the agreement, the extent of protections from liability ensured by the agreement, and any potential impacts the settlement agreement may have on the City.

Jennifer Paige, Deputy Director of Planning, responded to questions related to the project qualifications under a TPP.

Dale Goldsmith, Armbuster Goldsmith & Delvac LLP, and Brad Cox, Trammel Crow Company, responded to questions related to cleanup efforts at the site, including agreed upon mitigation between the developer and DTSC, as well as project site testing.

In response to Vice Mayor Kennedy's questions, Michele Beal Bagneris, City Attorney/City Prosecutor, responded that staff will review the referenced documents and report back to the City Council, however as a general rule staff would assert any immunities that are available to the City as the approver of the project.

Councilmember Gordo requested that City staff engage with Dr. Kristen Shrader-Frechette to share information. He also requested that the City Attorney provide information on the City's ability to demand complete testing/full remediation of the project site, and the ability to bring legal action against DTSC in the event their standards to not align with the City's standards. In addition, he asked staff to send DTSC a strongly worded letter objecting to

their dismissive response to the City's concerns and comments requesting additional time to review the DRAW report, and correspondence to their oversight authority.

Councilmember McAustin expressed concerns with DTSC not providing additional time for staff to review the DRAW and voiced support for Councilmember Gordo's request for the strongly worded letter.

Councilmember Masuda expressed concerns with the City being liable for an unsafe project site; and spoke on the need for deep water ground testing and full remediation at the project site.

Councilmember Wilson spoke on the need for the City Council to agree on a project by deferring to experts that the City trusts to determine a pathway forward.

The Mayor spoke on the various reports referenced by Dr. Kristen Shrader-Frechette related to the project site and stated he did not reach the same conclusions and does not agree with her statement to leave the site at its current state.

Councilmember Madison stated the need for the City Council to consider a standard to apply to the City Council for taking action, as salutary axioms were made during the discussion, however there is a legal frame work that needs to be considered. He asked staff to recommend qualified standards the City Council should apply in future discussions.

Following discussion, by consensus of the City Council, and on order of the Mayor, the information was received and filed, with direction given to staff as detailed above.

CONSIDERATION OF A CALL FOR REVIEW OF A BOARD OF ZONING APPEALS DECISION TO THE CITY COUNCIL REGARDING AFFORDABLE HOUSING CONCESSION PERMIT NO. 11869 TO FACILITATE THE CONSTRUCTION OF A NEW 94,165 SQUARE-FOOT, SIX-STORY, 92-UNIT, MULTI-FAMILY RESIDENTIAL BUILDING (INCLUDING EIGHT "VERY LOW INCOME UNITS"), WITH 131 PARKING SPACES IN A THREE-LEVEL SUBTERRANEAN PARKING GARAGE FOR THE PROPERTY LOCATED AT 253 SOUTH LOS ROBLES AVENUE (Mayor Tornek)

David Reyes, Director of Planning and Community Development, provided introductory comments, and Jennifer Paige, Deputy

OLD BUSINESS

Director of Planning, provided a PowerPoint presentation on the item, and jointly, responded to questions.

The Mayor stated his reasons and concerns for the project supporting his decision to submit the Call for Review (CFR) request to the City Council and to ensure the City Council understands the affordable housing concession permit process. He stated he will not recuse himself from discussion on the matter as he has not formed an opinion on the proposed project.

In response to Vice Mayor Kennedy's inquiry related to the projects representatives requesting recusals of members of the City Council, the City Attorney responded that staff does not issue rulings on allegations of bias, but suggested that those referenced in the correspondence could make statements to establish whether there is a basis for an allegation of bias or not.

Councilmember Wilson stated that he is familiar with the project, which is in Council District 6, and that the Madison Heights Neighborhood Association is an important constituency for him and Throop Unitarian Universalist Church has also approached him requesting residents in Council District 7 also review the project. He expressed concerns with the density bonuses in the proposed project and how the project fits into the neighborhood context, and would like to objectively review the information on the proposed project.

Councilmember Madison voiced support for the CFR, taking into consideration the City's policies and the unique circumstances of the project.

Erika Foy, Madison Heights Neighborhood Association, distributed correspondence and spoke in favor to call for review the Board of Zoning Appeals to the City Council.

<u>PUBLIC HEARING</u>: CITY MANAGER'S RECOMMENDED FISCAL YEAR 2020 OPERATING BUDGET AND THE FISCAL YEAR 2020 - 2024 CAPITAL IMPROVEMENT PROGRAM BUDGET

Recommendation:

(1) Open the public hearing on the City Manager's Recommended Fiscal Year (FY) 2020 Operating Budget and the FY 2020-2024 Capital Improvement Program (CIP) Budget; and

(2) Continue the public hearing to May 6, 2019 at 7:00 p.m. and thereafter at each subsequent meeting of the City Council until the City Council determines that the public hearing may close and then formally adopt the FY 2020 Operating Budget and FY 2020-2024 CIP Budget.

The City Clerk opened the public hearing; and reported that the public hearing notice was published in the <u>Pasadena Journal</u> and <u>Pasadena Weekly</u> on April 11, 2019; The City Clerk's office received one letter providing comment; which was distributed to the City Council, posted on line, and made part of the public hearing record.

City Manager Mermell presented a PowerPoint presentation on the item and responded to questions. Matt Hawkesworth, Director of Finance, provided information on the City's various departments, Full Time Equivalents (FTE's), trainees and MASH personnel; and responded to questions related to California Public Employees' Retirement System (CalPERS) investment return rates.

Vice Mayor Kennedy spoke on the need to establish a true baseline for the City's budget and encouraged the City Manager to recommend options to maintain fiscal stability and avoid potential deficits as projected in the next 4 or 5 years. He asked staff to provide detailed information on General Fund Expenses, including increases to the number of FTE's that have occurred since the "Great Recession" over the last ten years, and the impacts this has had on the City's pension obligation; and expressed concerns with incurring additional bond indebtedness. Vice Mayor Kennedy stated the following for the record: "We made a representation to public safety that we would start dealing with fire houses, retrofitting, and for God's sake if we haven't had a schedule for painting the Police Department we need to do that; the building looks like it's not getting the tender care that it deserves."

Councilmember Wilson echoed Vice Mayor Kennedy's comments related to the City's long-term fiscal stability strategies.
