Mayor Tornek called the regular meeting of the City Council to order at 6:31 p.m.

It was moved by Councilmember Gordo, seconded by Councilmember Masuda, to reconvene the City Council as newly constituted. (Motion unanimously carried) (Absent: None)

Vice Mayor Hampton acknowledged and thanked his family, recognized Cushon Bell, City Council District Liaison, City staff, and expressed appreciation to community partners, constituents, and colleagues for their support and assistance.

Following concluding remarks, the City Council recessed at 6:58 p.m. and reconvened at 7:04 p.m.

Following public comment, Councilmember McAustin clarified that the City Pasadena did not fast-track the development project at 3200 East Foothill Boulevard, and that the permit application was processed according to normal and regular development timelines.

Herman, residence not stated, made various comments related to free speech and homelessness.

Nancy Youngblut, Cheryl Auger, Ellen Finkelpearl, and Chris Peck, Pasadena residents, advocated for the City to ban single-use plastic (SUP) water bottles in the City, and spoke on the need for a new assessment of the City's waste stream.

City Manager Mermell responded to questions related to the percentage rate of items that are sorted and recycled in the City's recycle bins, and stated that a more thorough response will be provided in the weekly newsletter.

Councilmember McAustin, Chair of the Municipal Services Committee (MSC), informed the City Council that that staff will provide an update to MSC on the City's Zero Waste Plan, which will be forwarded to the City Council.

Councilmember Gordo requested that staff provide an update on recycling related apartment building dumpsters; and reiterated his request that all comments provided by the public speakers related the Space Bank project be included in to the City's comment letter to the State of California Department of Toxic Substances (DTSC) and to the City's consultants (Alta Environmental).

Boualem Bousseloub, Pasadena Sister Cities Ad Hoc Chair, expressed gratitude to Councilmember Kennedy for his assistance with the inclusion of the City's newest sister city, Dakar-Plateau, Africa; and spoke on the future visit of Mayor Ndoye and his delegation.

SET A DATE OF JUNE 10, 2019 FOR A PUBLIC HEARING FOR FROM COUNCIL RECOMMENDED ADJUSTMENTS TO THE ELECTRIC RATES COMMITTEES AND THE ELECTRIC UTILITY ASSISTANCE PROGRAM Recommendation:

(1) Find that the public hearing for the recommended adjustments to the electric rate structure is exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 15273 (Rates, Tolls, Fares, and Charges):

(2) Establish a date of June 10, 2019 to conduct a public hearing on the recommended adjustments to the electric rates and amendments to the Electric Utility Assistance Program effective July 1, 2019, or as practicable thereafter to:

a. Adopt and implement new fixed "Grid Access Charge" for all customers to generate annual revenue of approximately \$10.3 million; and

b. Amend the Electric Utility Assistance Program ("EUAP") to: (i) increase the basic benefit from \$7.50 per month to \$10.00 per month; and, (ii) change the low income program eligibility requirements as described in the agenda report.

Recommendation of the Municipal Service Committee: On April 23, 2019, the Municipal Services Committee approved staff's recommendation to the City Council. The Committee requested that additional electric bill comparison information (Attachment 1 to the agenda report) be included in the report to City Council. In response to discussion and questions that arose during the Committee meeting, additional cost and rate information has been included in the agenda report and attachments 2 and 3.

Herman, residence not stated, provided comment on the item.

Following discussion, it was moved by Councilmember Gordo, seconded by Councilmember McAustin, to set a public hearing date of June 10, 2019 on the item. (Motion unanimously carried) (Absent: Vice Mayor Hampton)

<u>CONTINUED PUBLIC HEARING</u>: CITY MANAGER'S RECOMMENDED FISCAL YEAR 2020 OPERATING BUDGET AND FISCAL YEAR 2020 – 2024 CAPITAL IMPROVEMENT PROGRAM BUDGET

<u>Recommendation</u>: It is recommended that the City Council receive public comment and continue the public hearing to each subsequent regular meeting of the City Council at 7:00 p.m. until June 17, 2019 or such other date as the City Council may determine, and at which time the City Council will be asked to close the public hearing and formally adopt the Fiscal Year (FY) 2020 Recommended Operating Budget and FY 2020-2024 CIP Budget.

The Mayor reported out on the discussion that took place at the special joint Finance Committee meeting earlier in the day, May 6, 2019 at 2:30 p.m., and noted the need to continue the review of the Pasadena Police Department as part of this evening's meeting deliberations.

Police Chief John Perez responded to questions related to personnel recruitment, police motor groups, training, license plate readers, civilianization plans for the Department, and training. City Manager Mermell responded to questions related to the City's general fund and tax dollar fund allocations. He stated that he will provide additional information on the Pasadena Police

Department's (PPD) FY 2020 proposed budget, including the five Full Time Equivalents (FTE) in administration, which includes reallocations; and internal service charges for field operation to the City Council.

Councilmember Kennedy requested a detailed organizational chart of the Pasadena Police Department. He spoke on the safety concerns he has received from his constituents related to Washington Park, and spoke in support of Councilmember Gordo's request for additional resources to be assigned to park safety and security. Councilmember Kennedy asked staff to seriously consider and push for a civilianization program for the Department.

Councilmember Madison stated the need for the PPD to prioritize safety concerns including homelessness, gangs, and violence. He spoke on the importance of having a fully staff Police Department that will include additional motor officers; and suggested dedicating the same percentage of new tax dollars generated from sales tax increase to the PPD as the general fund.

Councilmember Gordo suggested that staff to research the City of Los Angeles' carve-out (a labor-management alternative workers' compensation program) module as a possible program to emulate in the City, which is a cost saving measure.

COUNCIL COMMENTS

Councilmembers Gordo and Madison asked the City Attorney to provide information on what can be done to protect employees from individuals who are using offensive and inciting language when making public comment, including directing offensive comments to specific employees who are at their workplace. Added to this information is the role and duties of the City Council to protect employees from a hostile or abusive work environment. Councilmember Kennedy asked staff to provide information to the City Council on the Supreme Court's rulings related to hate speech, including the definition and protection of offensive language under the 1st Amendment. He expressed serious concerns that the reprehensible behavior of such public speakers may result in violence by other public members.

The Mayor spoke on the Pasadena Alliance of African American School Educators (PAAASE) held their 16th annual Rites of Passage Scholarship Awards event held on Sunday May 5, 2019. He reminded the community that the City is recognizing May 2019 as "Mental Health Month", with Mental Health Day to occur on Saturday, May 18, 2019 at the Pasadena Central Library including a series of educational programs.
