Dear Mayor and City Council,

I am writing to express my support for the institution of a moratorium on no-fault evictions and thank you in advance for voting for its passage.

While AB 1482 has a provision that rolls back rent increases imposed after March 15, 2019, to percentages allowable under the new law, it does not have retroactive protections for the "just cause" eviction portion of the law. Thus, it is vital that cities institute moratoriums on no-fault evictions until Jan. 1, 2020 when AB 1482 takes effect. Just as vital, any emergency ordinance placing a moratorium on no-fault evictions should be retroactive to at least March 15, 2019, when serious discussion of and momentum for the passage of AB 1482 began, likely prompting predatory landlords to begin posthaste the eviction preemption process of AB 1482.

For this reason, I support the draft ordinance submitted by the Pasadena Tenants Union and the Pasadena Tenant Justice Coalition. I hope that the Pasadena City Council will also support this ordinance or at least include language in whatever ordinance they adopted that provides for tenant eviction protections pre-October 08, 2019.

The Foothill Apartment Association does not oppose the Tenant Protection Act Temporary Adoption Ordinance. We cannot support the ordinance either and felt it necessary to register our reasons for withholding that support.

We have been monitoring the situation concerning the passing and signing of AB 1482 and find no evidence of an uptick in terminations of tenancy or evictions, let alone a "surge" of such actions in the City of Pasadena. We have seen a higher than normal request rate for our Change in Terms of Tenancy form, which landlords use to increase rent, but that is all. This is in no way abnormal given that a great many of our members' units are below market rental rates.

On the whole, the members of this Association, the majority of which are "mom and pop" small business owners, have relayed that the terms of the new law (AB 1482) will not greatly impact their current business models.

Referring directly to the October 28<sup>th</sup> City Council meeting and the General Public Comments. Every person who spoke with a specific grievance, to the best of my knowledge, qualifies for relocation fees under the Pasadena Tenant Protection Ordinance (9.75.060, item 2) a) b) or c)) enacted by this Council and supported by our Association. Please note that in each of these situations the cause was that of ownership turnover.

The PTU and the PTJC continue to advance a narrative of greedy landlords and a deaf City Council in order to attempt to bring hard rent control to Pasadena. What is at issue is the landlord tenant relationship and ultimately the character of this city. Looking at the facts and very real numbers, we have one of, if not *the*, healthiest cities in southern California.

There is an affordable housing crisis here and in every other large metropolitan hub in the nation, to be sure, but the Pasadena City Council's consistent efforts and victories in the areas of affordable housing, the expansion of inclusionary housing, resources for the homeless, and tenant/landlord relations are exemplary, to say the least.
