

**RESOLUTION NO.**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASADENA, CALIFORNIA, DECLARING THE RESULTS OF THE CITY'S PRIMARY NOMINATING MUNICIPAL ELECTION HELD ON TUESDAY, MARCH 3, 2020**

WHEREAS, a Primary Nominating Municipal Election for the Office of Mayor and members of the City Council in Districts 1, 2, 4, and 6 of the City of Pasadena was called by the City Council to be held on March 3, 2020; and

WHEREAS, the Los Angeles Registrar Recorder/County Clerk conducted said election on behalf of the City, canvassed the returns, and certified the results of said election, and those results are attached as "Exhibit A" and incorporated herein by reference; and

WHEREAS, the City Clerk has submitted the certified results of said canvass to the City Council of the City of Pasadena.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pasadena that:

1. The following be declared to be the results of the Primary Nominating Election for the Office of Mayor and members of the City Council, Districts 1, 2, 4, and 6:

2. That Tyron Hampton, having received a majority of the total votes cast for candidate for the office of Member of the City Council from District 1, from which the candidate sought nomination, hereby is declared to be re-elected as Member of the City Council from District 1 for a full term of four years. The term of office shall begin on Monday, December 7, 2020, the 5<sup>th</sup> Monday following the November 3, 2020 General Municipal Election.

3. That Felicia Williams, having received a majority of the total votes cast for candidates for the office of Member of the City Council from District 2, from which the candidate sought nomination, hereby is declared to be elected as Member of the City Council from District 2 for a full term of four years. The term of office shall begin on Monday, December 7, 2020, the 5<sup>th</sup> Monday following the November 3, 2020 General Municipal Election.

4. That Gene Masuda, having received a majority of the total votes cast for candidates for the office of Member of the City Council from District 4, from which the candidate sought nomination, hereby is declared to be re-elected as Member of the City Council from District 4 for a full term of four years. The term of office shall begin on Monday, December 7, 2020, the 5<sup>th</sup> Monday following the November 3, 2020 General Municipal Election.

5. That Steve Madison, having received a majority of the total votes cast for candidates for the office of Member of the City Council from District 6, from which the candidate sought nomination, hereby is declared to be re-elected as Member of the City Council from District 6 for a full term of four years. The term of office shall begin on Monday, December 7, 2020, the 5<sup>th</sup> Monday following the November 3, 2020 General Municipal Election.

6. That Victor M. Gordo and Terry Tornek, being the two persons receiving the highest number of votes for the Office of Mayor, shall be the candidates for election for the Office of Mayor at the City’s General Municipal Election on November 3, 2020.
